RESOLUTION RECOMMENDING THE AWARD OF CONTRACT TO INSTANT STRUCTURES INC. THROUGH DIRECT CONTRACTING UNDER ALTERNATIVE METHODS OF PROCUREMENT IN THE PROCUREMENT OF PREFABRICATED BUILDING FOR HOUSING PROJECT OF THE PROVINCIAL GOVERNMENT OF ISABELA USE

WHEREAS, as a general rule, all procurement shall be done through competitive bidding except resort to any of the alternative methods of procurement may be allowed when justified by the conditions in order to promote efficiency and economy;

WHEREAS, Rule XVI Section 50 of R.A 9184, otherwise known as the Government Procurement Reform Act, provides for Direct Contracting as an Alternative Method of Procurement of Goods;

WHEREAS, Direct Contracting or single source procurement is a method of procurement of Goods that does not require elaborate Bidding Documents;

WHEREAS, Procurement of Goods of proprietary nature which can be obtained only from the proprietary source, i.e. when patents, trade secrets, and copyrights prohibit others from manufacturing the same item;

WHEREAS, the supplier is simply asked to submit a price quotation or a pro-forma invoice together with the conditions of sale. The offer may be accepted immediately or after some negotiations

WHEREAS, upon obtaining the price quotation, the BAC has validated the technical, legal and financial capabilities of supplier to supply and deliver the items to be procured;

WHEREAS, upon confirmation of such capabilities and after due deliberation of the submitted price quotation, the BAC found the offer of INSTANT STRUCTURES INC. to be the single calculated and responsive quotation;

NOW, THEREFORE, THE BIDS AND AWARDS COMMITTEE RESOLVES AS IT HEREBY RESOLVED, TO RECOMMEND TO THE PROVINCIAL GOVERNMENT OF ISABELA, REPRESENTED BY THE GOVERNOR, HON. RODOLFO T. ALBANO III, THE AWARD OF CONTRACT TO INSTANT STRUCTURES INC. THROUGH DIRECT CONTRACTING UNDER ALTERNATIVE METHODS OF PROCUREMENT IN THE PROCUREMENT OF PREFABRICATED BUILDING FOR HOUSING PROJECT OF THE PROVINCIAL GOVERNMENT OF ISABELA USE, PURSUANT TO AND IN ACCORDANCE WITH SECTION 50 OF R.A. 9184;
