RESOLUTION RECOMMENDING THE AWARD OF CONTRACT TO ISAIAH 8:15 ENTERPRISES WITH PR NO. 100-2025-03-0344 AMOUNTING ₱102,070.00 THROUGH DIRECT ACQUISITION UNDER MODES OF PROCUREMENT IN PROCURING VARIOUS ITEMS FOR PROCUREMENT OF STORAGE FACILITY EQUIPMENT, LOGISTIC FOR WAREHOUSE MANAGEMENT USE

WHEREAS, as a general rule, all procurement shall be done through competitive bidding except resort to any of the Modes of Procurement or Negotiated Procurement which may be allowed when justified by the conditions in order to promote efficiency and economy;

WHEREAS, Rule IV Section 26.1(f) of the IRR. of R.A 12009, otherwise known as The New Government Procurement Act, provides for Direct Acquisition; as one of the modes of procurement consistent with the Fit-for-Purpose procurement approach;

WHEREAS, Section 32.1 of the said IRR stated that Direct Acquisition is a mode of procurement of CSE not available in the PS-DBM, Non-CSE, and services with ABC not exceeding Two Hundred Thousand Pesos (₱200,000.00), where the Procuring Entity, without need to conduct a canvass or request for quotations, may procure directly from any known and reputable sources;

WHEREAS, the BAC has deemed it proper to conduct Direct Acquisition as an alternative mode of procurement in the interest of efficiency and economy, pursuant to Section 31.1 of the IRR of R.A No. 12009;

WHEREAS, upon examination of PR NO. 100-2025-03-0344, the BAC found out that the items for procurement are classified as CSE not available in the PS-DBM, non-CSE or Services not Exceeding Two Hundred Thousand Pesos (₱200,000.00);

WHEREAS, pursuant to the guidelines under Sections 32.2 and 32.3 of the IRR of R.A No. 12009, the BAC found ISAIAH 8:15 ENTERPRISES to be a reputable source with legal, technical, and financial capacity and eligible for the supply and delivery of VARIOUS ITEMS FOR PROCUREMENT OF STORAGE FACILITY EQUIPMENT, LOGISTIC FOR WAREHOUSE MANAGEMENT USE

NOW, THEREFORE, THE BIDS AND AWARDS COMMITTEE RESOLVES AS IT HEREBY RESOLVED, TO RECOMMEND TO THE PROVINCIAL GOVERNMENT OF ISABELA, REPRESENTED BY THE GOVERNOR, HON. RODOLFO T.
