RESOLUTION RECOMMENDING THE AWARD OF CONTRACT TO POLYMER LIVESTOCK SUPPLY WITH PR NO. 100-2025-03-427 AMOUNTING ₱918,000.00 THROUGH SMALL VALUE PROCUREMENT UNDER NEGOTIATED PROCUREMENT IN PROCURING HEMORRHAGIC SEPTICEMIA VACCINE FOR PREVENTION AND CONTROL OF HEMORRHAGIC SEPTICEMIA IN LARGE ANIMALS IN THE PROVINCE OF ISABELA USE

WHEREAS, as a general rule, all procurement shall be done through competitive bidding, provided that resort to any of the other modes of procurement may be allowed when justified by the conditions in order to promote efficiency and economy;

WHEREAS, Section 26.1(h) of the Implementing Rules and Regulations (IRR) of R.A 12009, otherwise known as the New Government Procurement Act, provides for Small Value Procurement as one of the modes of Procurement consistent with the Fit-for-Purpose procurement approach;

WHEREAS, Section 34 of the said IRR states that Small Value Procurement is a mode of procurement whereby the Procuring Entity Procuring Entity requests for the submission of at least three (3) price quotations for Goods not available in the PS-DBM, Infrastructure Projects, and Consulting Services. The receipt of one (1) quotation is sufficient to proceed with the evaluation of bidders: Provided, That, the amount involved does not exceed Two Million Pesos (₱2,000,000.00), subject to the periodic review of the threshold amount and adjustments as may be deemed appropriate by the GPPB;

WHEREAS, pursuant to Section 34.3 of the said IRR, the End-User or Implementing Unit has submitted a request for Small Value Procurement to the Bids and Awards Committee (BAC) indicating the Technical Specifications, Scope of Work, Approved Budget for the Contract and other terms and conditions;

WHEREAS, upon evaluation of the prepared ABC under PR NO. 100-2025-03-427 the BAC has found that the amount involved does not exceed the threshold amount of Two Million Pesos (₱2,000,000.00) pursuant to Section 34.2 of the said IRR;

WHEREAS, in compliance with section 34.3 of the said IRR, the BAC has prepared and sent Requests for Quotations (RFQ) of Requests for Purchase (RFPs) to at least three (3) suppliers of known qualifications;

WHEREAS, in response to the required postings, the following submitted their respective proposals:

WHEREAS, upon confirmation of such capabilities and after due deliberation of the submitted price quotations, the BAC found the offer to POLYMER LIVESTOCK SUPPLY to be the lowest calculated and responsive bid;

NOW, THEREFORE, THE BIDS AND AWARDS COMMITTEE RESOLVES AS IT HEREBY RESOLVED, TO RECOMMEND THE PROVINCIAL GOVERNMENT OF ISABELA, REPRESENTED BY THE GOVERNOR, HON. RODOLFO T. ALBANO III, THE AWARD OF CONTRACT TO POLYMER LIVESTOCK SUPPLY THROUGH SMALL VALUE PROCUREMENT UNDER NEGOTIATED PROCUREMENT IN PROCURING HEMORRHAGIC SEPTICEMIA VACCINE FOR PREVENTION AND CONTROL OF HEMORRHAGIC SEPTICEMIA IN LARGE ANIMALS IN THE PROVINCE OF ISABELA USE, PURSUANT TO AND IN ACCORDANCE WITH SECTION 34 OF R.A 12009;
