**EXECUTIVE ORDER NO. 08**

**REORGANIZING THE PROVINCIAL COMMITTEE ON  
ANTI-RED TAPE IN THE PROVINCE OF ISABELA**

**Whereas**, Republic Act No. 11032 otherwise known as the "Ease of Doing Business and Efficient Government Service Delivery Act of 2018", mandates all government agencies to adopt simplified requirements and procedures that will reduce red tape and expedite business and non-business-related transactions;

**Whereas**, pursuant to Section 5 of R.A. 11032, all offices and agencies which provide government services are hereby mandated to regularly undertake cost compliance analysis, time and motion studies, undergo evaluation and improvement of their transaction systems and procedures and reengineer the same if deemed necessary to reduce bureaucratic red tape and processing time;

**Whereas**, the Anti-Red Tape Authority (ARTA) issued Memorandum Circular No. 2020-07 Series of 2020 as amended by Memorandum Circular No. 2023-08 Series of 2023, directing all government offices to designate a committee on Anti-Red Tape (CART) and providing the guidelines thereof;

**Whereas**, ARTA Memorandum Circular 2021-09 was issued to provide information on the adoption and endorsement of the Whole-of-Government (WOG) Reengineering Manual to guide agencies and offices towards adopting a whole-of-government approach in the streamlining and reengineering of their systems and procedures in compliance with Section 5 of R.A. 11032;

**Whereas**, the reengineering process also entails an interagency review and harmonization of permitting and licensing laws, policies, regulations and issuances to eliminate redundant and undue regulatory burdens to the transacting public;

**Whereas**, the Committee on Anti-Red Tape shall ensure that the agency receive, respond, and comply with the requirements of R.A. 11032, its IRR and subsequent issuance by ARTA, as may be applicable, and in coordination with the appropriate offices;

**NOW THEREFORE, I, RODOLFO T. ALBANO III**, Governor of the Province of Isabela by the powers vested in me by law, do hereby re-organize the Provincial Committee on Anti-Red Tape as follows:
