

## Contract Agreement

**THIS AGREEMENT**, made on the 1st day of June 2021 between the **Provincial Government of Isabela** with office address at Provincial Capitol, Alibagu, City of Ilagan, Isabela (hereinafter called the "Entity")

and

**Isaiah 8:15 Enterprises** represented by **Ms. Irish Jane T. Cristobal**, Proprietor, with office address at **District II, Cauayan City, Isabela**.

**WHEREAS**, the Entity has invited the Bidder for the **Supply and Delivery of Fourteen (14) units Laptop, Intel Core i5 8250U Processor (6m cache uot to 3,4 GHz), NVIDIA GF MX 150 2gb GDDR5 VRAM, 8th Gen, 14" FHD 1920 x 1080, 16:9 matte display, 4GB DDR4 Memory, 1TB HDD + 256GB SSD, Windows 10 Home with Printer Dot Matrix LX 310** for the Province of Isabela (hereinafter called "the Goods") for which the entity accepted the Bid amounted to **One Million One Hundred Seventy Two Thousand Five Hundred Pesos and 00/100 (Php1,172,500.00)** of the Supplier for the provision and completion of such goods.

### **NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:**

1. In this Agreement, words and expressions shall have the same meaning as are respectively assigned to them in the Conditions of Contract hereinafter referred to.

  - (d) Invitation to Apply for Eligibility and to Bid;
  - (e) Instructions to Bidders;
  - (f) Bid Data Sheet;
  - (g) Addenda and/or Supplemental/Bid Bulletins, if any;
  - (h) Bid form and Price Schedule, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes;
  - (i) Eligibility requirements, documents and/or statements;
  - (j) Performance Security;
  - (k) Notice of Award of Contract and the Bidder's Conforme thereto;
  - (l) Other contract documents that may be required by existing laws and/or the Entity.
3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and to remedy defects therein in conformity with the provisions of this Contract in all respects.
4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the time and in the manner prescribed by this Contract.
