

Contract Agreement

THIS AGREEMENT, made on DEC 05 2022 between the **Provincial Government of Isabela** with office address at Provincial Capitol, Alibagu, City of Ilagan, Isabela (hereinafter called the "Entity")

and

Aves Farm Supply and General Merchandise, represented by **Ms. Jenny Ann A. Garcia**, Proprietor, with office address at **Roxas St., District II, Cauayan City, Isabela**.

WHEREAS, the Entity has invited the Bidder for the **Supply and Delivery of 622 Heads Gilt** for the Province of Isabela (hereinafter called "the Goods") for which the entity accepted the Bid for **Twenty Seven Million Eight Hundred Ninety Six Thousand Seven Hundred Pesos & 00/100 (₱27,896,700.00)** of the Supplier for the provision and completion of such goods.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meaning as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents shall be attached, deemed to form, and be read and construed as part of this Agreement, to wit:
 - (a) General and Special Conditions of Contract;
 - (b) Schedule of Requirements;
 - (c) Technical Specifications;
 - (d) Invitation to Apply for Eligibility and to Bid;
 - (e) Instructions to Bidders;
 - (f) Bid Data Sheet;
 - (g) Addenda and/or Supplemental/Bid Bulletins, if any;
 - (h) Bid form and Price Schedule, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes;
 - (i) Eligibility requirements, documents and/or statements;
 - (j) Performance Security;
 - (k) Notice of Award of Contract and the Bidder's Conforme thereto;
 - (l) Other contract documents that may be required by existing laws and/or the Entity. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and to remedy defects therein in conformity with the provisions of this Contract in all respects, such as:
 - i. Stocks must come from accredited and reputable piggery.
 - ii. Stocks must be vaccinated against the following diseases:
 - a. Hog Cholera
 - b. Mycoplasma
 - c. Actinobacillus pleuropneumonia

- d. Pseudorabies
- e. Swine Parvo Virus
- f. Porcine Respiratory Reproductive Syndrome
- g. Porcine Corona Virus
- iii. The stocks must be accompanied by a laboratory result indicating that they are tested negative from African Swine Fever (ASF) as least two(2) weeks prior to delivery.
- iv. The Supplier shall deliver the gilts at the designated area of distribution.
- v. Inspection and acceptance of the Gilts shall be made upon delivery.
- vi. The Supplier must agree to replace the animals that died within two (2) months after delivery.
- vii. With hauling.

4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the time and in the manner prescribed by this Contract.


