

# CONTRACT AGREEMENT

**THIS AGREEMENT**, made this 31<sup>st</sup> day of May, 2022, between the **PROVINCIAL GOVERNMENT OF ISABELA**, with office address at the Provincial Capitol Compound, Alibagu, Ilagan City, Isabela, hereinafter called the "Entity";

And

**Dragon Twelve Builders & Construction Supply** represented by **MR. JONATHAN L. DIAZ**, Proprietor with office address at **Arranz St. Calamagui 2<sup>nd</sup>, City of Ilagan, Isabela**, hereinafter called the "Contractor";

WHEREAS, the Entity is desirous that the Contractor shall execute the **Lot 10- Construction of Slope Protection along Malalam-San Antonio Provincial Road Near the San Antonio Region Public Cemetery, Centro San Antonio, City of Ilagan, Isabela** (hereinafter called "the Works") and the Entity has accepted the Bid for **One Million Nine Hundred Ninety Six Thousand Five Hundred Ninety Seven Pesos & 67/100 (Php1,996,597.67)** of the Contractor for the execution and completion of the work and the remedying of any defects therein.

## NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:


1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The entirety if the WORKS comprised on this Contract Agreement shall be completed within **Fifty (50)** calendar days in accordance with the provision of the Bid Documents
3. The following documents shall be attached, deemed to form, and be read and construed as integral part of this Agreement, to wit:
  - (b) General and Special Conditions of Contract;
  - (c) Drawings/Plans;
  - (d) Specifications;
  - (e) Invitation to Bid;
  - (f) Instructions to Bidders;
  - (g) Bid Data Sheet;
  - (h) Addenda and/or Supplemental/Bid Bulletins, if any;
  - (i) Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
  - (j) Eligibility requirements, documents and/or statements;
  - (k) Performance Security;
  - (l) Notice of Award of Contract and the Bidder's conforme thereto;
  - (m) Other contract documents that may be required by existing laws and/or the Entity.
4. In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Entity to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.

5. The Entity hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.




