In consideration for the sum of Two Million Ninety-Six Thousand One Hundred Sixty-Nine Pesos & 00/100 (P2,096,169.00) or such other sums as may be ascertained, Isaiah 8:15 Enterprises agrees to supply and deliver Various Information and Communication Technology Equipment in accordance with its Bid.
