- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- In consideration for the sum of Two Million Eight Hundred Seventy Five Thousand Pesos & 00/100 (P2,875,000.00) or such other sums as may be ascertained, ISAIAH 8:15 ENTERPRISES agrees to supply and deliver the Sacks in accordance with its Bid.
- 4. The **Provincial Government of Isabela** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
