3 Bidding will be conducted through open competitive bidding procedures using a non-discretionary "Pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulation (IRR) of Republic Act RA 9184, otherwise known as the "Government Procurement Reform Act". Bidding is restricted to Filipino Citizen / sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines and to citizens or organization of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183. Bidding is open to all; interested whether local or foreign subject to the conditions for eligibility provided in the IRR of RA 9184.

4 Interested bidders may obtain further information from Provincial Government of Isabela and inspect the Bidding Documents at the address given below during 8:am to 5:00p.m.

5 A complete set of Bidding Documents may be acquired by interested Bidders on June 14, 2018 and before the deadline of dropping of bids form on the address below and upon payment of non-refundable fee for the Bidding Documents.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the bidding Documents not later than the submission of their bids.

6 The Provincial Government of Isabela will hold a Pre- Bid Conference on June 25, 2018 at BAC Office, PGSO Bldg., Alibagu, City of Ilagan, Isabela, which shall be open to prospective bidders.

7 Bid must be duly received by the BAC Secretariat at the address below on or before July 11, 2018. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18

Bid opening shall be on July 11, 2018 at the BAC Office, PGSO Bldg., City of Ilagan, Isabela. Bids will be opened in the presence of the Bidder's representatives who choose to attend at the address below. Late bids shall not be accepted.

8 The Provincial Government of Isabela reserves the right to reject any and all bids, declare a failure of bidding or not award the contract at any time prior to contract award in accordance with section 4 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
