Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The Provincial Government of Isabela now invites bids for the above Procurement Projects. Delivery of the Goods is required for 30 calendar days. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184;
4. **a)** Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183. Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the IRR of RA 9184.
5. Prospective bidders may obtain further information from the Provincial Government of Isabela and inspect the Bidding Documents at the address given below between **8:00 a.m. and 5:00 p.m.;**
6. A complete set of Bidding Documents may be acquired by interested Bidders on **December 10, 2024**, from the given address and website below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB. The Procuring Entity shall allow the bidder to present its proof of payment for the fees.
7. **PRE-BID CONFERENCE** shall be on **December 17, 2024, at 10:00 a.m.**, at the BAC Office located at the PGSO Building, Alibagu, City of Ilagan, Isabela. The Bids of the

Interested Bidders must be submitted to the BAC Secretariat on or before the scheduled Opening of Bids;

8. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below on or before **10 A.M. on January 6, 2025**. Late bids shall not be accepted;
9. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14;
10. **BID OPENING** shall be on **January 6, 2025**, at around **10:30 a.m.** in the BAC Office and will be made in the presence of the Bidders/Representatives who choose to attend therein. Any effort by a bidder to influence the Procuring Entity in its decision with respect to the bid evaluation, bid comparison, or contract award will result in the rejection of the Bidder's bid;
