Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the revised Implementing Rules and Regulations (IRR) of Republic Act No. 12009.
4. Interested bidders may obtain further information from Provincial Government of Isabela and inspect the Bidding Documents at the address given below from 8:00 am. to 5:00 pm.
5. A complete set of Bidding Documents may be acquired by interested bidders on **August 5, 2025** from given address and website/s below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB. The Procuring Entity shall allow the bidder to present its proof of payment for the fees.
6. **Pre-Bid Conference** shall be on **August 13, 2025**, 10:00 A.M. at the BAC Office located at PGSO Building, Alibagu, City of Ilagan, Isabela. The Bids of the Interested Bidders must be submitted to the BAC Secretariat on or before the scheduled Opening of Bids.
7. Bids must be duly received by the BAC Secretariat through manual submission at the office address as indicated below or on or before 10:00 A.M. on **August 27, 2025**. Late bids shall not be accepted.
8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 16.
9. **Bid opening** shall be on **August 27, 2025** at around 10:30 A.M. in the BAC Office and will be made in the presence of the Bidders/Representatives who choose to attend therein. Any effort by the bidder to influence the Procuring Entity in its decision with respect to the bid evaluation, bid comparison, or contract award will result in the rejection of the Bidder’s bid.
