**HIGHLIGHTS OF ACCOMPLISHMENT RE: TODAS DENGUE, TODO NA 'TO**

In observance of the National Disaster Consciousness Month and in line with the Executive Order No. 23 and Memorandum No. 40 series of 2015 by the Honorable Governor, the Environment and Natural Resources Office (ENRO) actively participated in the conduct of Clean up Drive and Blood-Letting Activities as part of the multi-sectoral project dubbed as "TODAS DENGUE, TODO NA 'TO – Ikalawang Kagat".

On July 10, 2015, twenty-six (26) members of the ISEP-TF and ENRO personnel underwent screening at the Isabela Provincial Hospital, of which thirteen (13) was allowed for blood donation. Other personnel proceeded to the ENR Office and conducted clean-up drive within the periphery of the ENRO building and its facilities.



Steered actively by For. Geronimo P. Cabaccan, Jr., ENR Officer, the ENRO personnel together with the other members of ISEP-TF executed clean-up activities to include tree branch trimming and grass cutting along the waterways to elude possible breeding areas for mosquitoes. Potted floras were also replanted to reduce density and hiding sites for dengue-carrier insects.



The ENR Officer also enjoined the Philippine League of Local Environment and Natural Resources Officers (PLLENRO) – Isabela Chapter to support and participate in the said activities at their respective Local Government Units. Accomplishment reports shall be presented during the League's regular monthly meeting.



While coordinating with the different Secondary School Principals for the scheduling of the Aral Kalikasan sa Eskwela, we reiterated on the strict adherence to the above mentioned Executive and Memorandum of the Provincial Governor.
