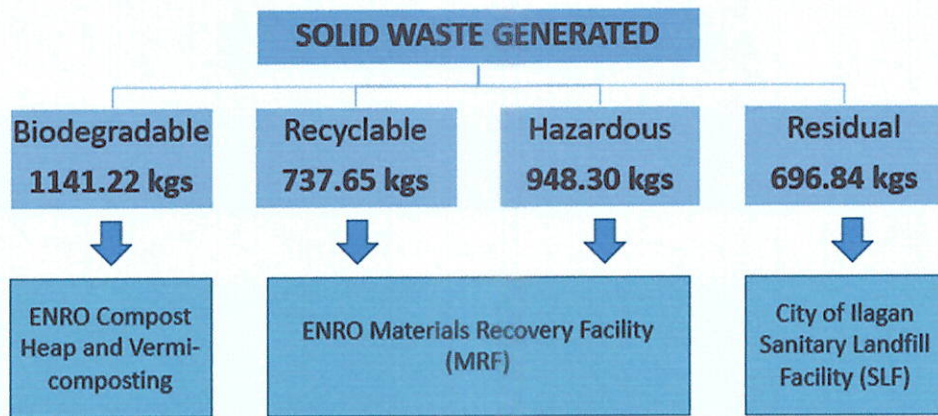

A total of **3524.01 kilograms** (recyclable, residual, hazardous, and biodegradable) were collected and disposed through the ENRO MRF, Compost Heap and Vermicomposting Facilities and to the City of Ilagan Sanitary Landfill Facility (SLF).

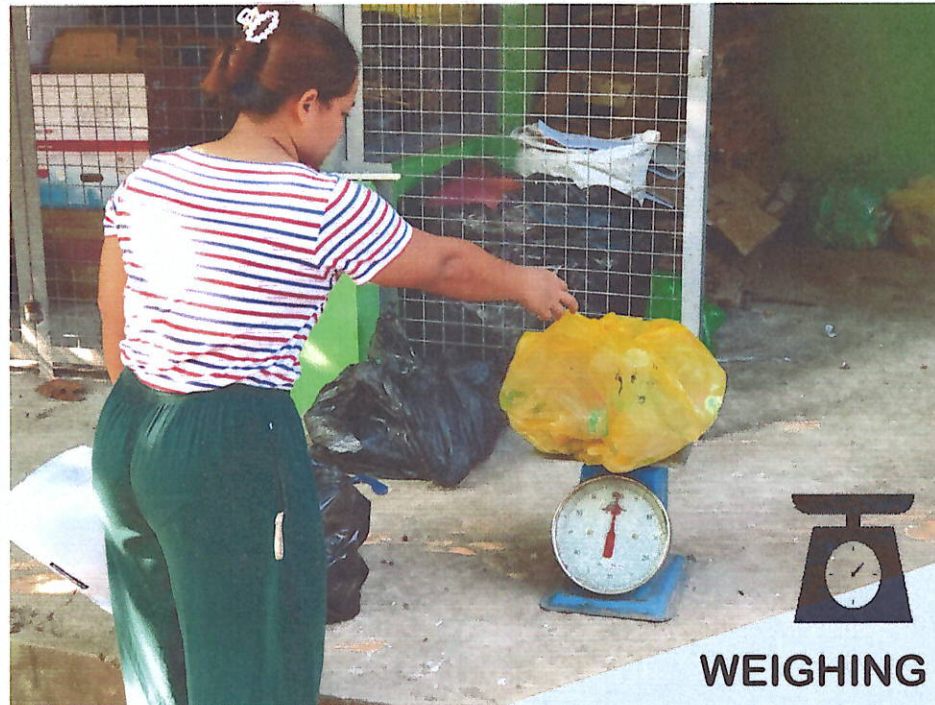
