The registration started upon arrival of participants coming from the nineteen (19) Barangays of Luna. The opening program started a few minutes before 9:00 o'clock in the morning and followed immediately with the orientation by the different focal persons on the basic services that can be availed by the community. The first speaker was Mr. Tumamao of OPA who used the "Bayong" to present in a nutshell all the services the farmer can avail from the Provincial Government and where he can put it all together in a package to start from his farming activities or in Agriculture (BROs ASP, PPP, PSP, LAMFP, PAIWI and livelihood); Health (BROs Healthcare & PhilHealth); Insurance (BROs PNB Gen & SSS) and Scholarship (BRO Education) for their children. After which, it was followed by the brief presentation of focal persons with their respective services.

Soon as the Provincial Governor Hon. Faustino G. Dy III and the Vice Governor Hon. Antonio T. Albano arrived, the Municipal Mayor, Hon. Jaime Atayde gave his welcome address to all the participants. The Governor then delivered his most awaited message after which awarded the financial assistance to the nineteen (19) Barangays in support of the programs and projects being implemented at the Barangay level. An intermission number was also rendered by the IGLO members of Mambabanga to entertain everyone.

The presentation of other services continued and just after the lunch break, the table in each booth were declared open to act on all requests received from the clients.
