Submitted herewith is the Year End Accomplishment Report of Isabela Provincial Jail covering the period from January 1, 2018 to December 31, 2018.


I. PRIMARY:

a. Inmates Escort and Security:

For the period, a total of **Five Thousand Four Hundred Twelve (5,412)** or an average of Four hundred Fifty One (451) inmates/detainees monthly were escorted and secured while attending Court hearings in Twelve (12) Regional Trial Courts; One (1) Municipal Trial Courts in Cities (MTCC) and Seven (7) Municipal Circuit Trial Courts in the Province of Isabela and Two (2) Regional Trial Courts in Metro Manila.

b. Delivery of Insular Prisoners:

For the period, this Jail shipped a total of **Twenty Six (26)** Insular Prisoners to National Bilibid Prison (NBP) Muntinlupa City. **Sixteen (16) last February 2018; Three (3) last April 2018**; **One (1) last July 2018 and Six (6) last October 2018.** These Insular Prisoners will served their respective Sentences thereat.








Fig. 1- Photograph showing **three (3)** insular Prisoners committed at National Bilibid Prison Muntinlupa City last February 2018. (From Left to right) 1. Paquito Jose; 2. Roger Discargar and 3. Herson Dalit.


















FIG. 2- Photograph showing **seven (7)** insular Prisoners committed to National; Bilibid Prison (NBP) Muntinlupa City last **February 2018.** (From left to right) 1. Regimer Bautista; 2. Roberto Madria Jr.; 3. Nicole John Navarro; 4. Jeffrey Calumpit; 5. Kevin Calumpit; 6. Bonofacio Lubo and 7. Wilfredo Mateo.















Fig. 3- Photograph showing **six (6)** insular Prisoners committed to National Bilibid Prison (NBP) Muntinlupa City last **February 2018**. (from left to right) 1. Narciso Sejalbo; 2. Allan Soliven; 3. Elvin Ray Masigan II; 4. Romeo Palingayan; 5. Ernesto Pasandan and 6. Teofilo Antonio








Fig. 4- Photograph showing **Three (3)** inmates committed to National Bilibid Prison last month of April 2018. (from left to right) 1. Joseph Andres; 2. Ace Bautista and 3. Andres Aggabao.

c. Commitment of Prisoners:

For the period, a total of **Three Hundred Sixteen (316)** inmates/detainees or an **average of 26 inmates** per month were committed and received in this Jail charged with various offenses and emanates from the different Regional Trial Courts in the province of Isabela.

d. Decongestion of Prisoners:

For the period, a total of **Four Hundred Fifteen (415)** inmates/detainees or an average of **Thirty Four (34)** inmates/detainees per month were released/discharged from the custody of this jail by virtue of a Court Order.

II. SECONDARY

a. Health Program

For the period, **Four Thousand Seven Hundred Seven (4,707**) inmates/ detainees or an average of **Three Hundred Ninety Two (392)** inmates per month were taken blood Pressure.

A total of **Two Thousand Fifty Five (2,055)** inmates/detainees or an average of **One Hundred Seventy One (171)** inmates per month were recipient of assorted medicines/capsules/vitamins.

A total of **Thirty Nine (39)** inmates/detainees or an average of **Three (3)** inmates/detainees per month were recipient of First Aid.

A total of **Sixty Seven (67)** inmates/detainees or an average of **Five (5)** inmates/detainees per month were brought to Gov. Faustino N. Dy Sr. Memorial Hospital, City of Ilagan, Isabela for treatment of various sickness/illness and some were confined with proper escort.

A total of **Twenty Five (25)** inmates/detainees were recipient of Dental Services (tooth extraction) on the month of January 2018.




Fig. 4. Photograph showing the Provincial Dental Health Bus that were used as mobile Dental Clinic in the conduct of Tooth extraction at Isabela Provincial Jail.

b. Livelihood Program:

For the period , livelihood program was undertaken by way of continuous involvement in handy craft project like basket, fruit tray, purse, shoulder bags, key chain and others using kogon, plastic beads and recycled wrappers of 3 in 1 coffee as their major materials and the finished products of which are displayed in public for sale. Other inmates/detainees were engaged in poultry, duck, goat and pig raising inside the perimeter fence of Isabela Provincial Jail.
