Submitted herewith is the Year End Accomplishment Report of Isabela Provincial Jail covering the period from January 1, 2020 to December 31, 2020, with a total number of 245 Person Deprived of Liberty (PDL).

## I. PRIMARY:


#### a. Inmates/PDLs Escort and Security:

For the period, a total of **One Thousand Eight Hundred Seventy-seven** (1,877) or an average of One Hundred Fifty-Six (156) inmates/PDLs per month were escorted and secured while attending Court hearings in Twelve (12) Regional Trial Courts: One (1) Municipal Trial Courts in Cities (MTCC) and Seven (7) Municipal Circuit Trial Courts in the Province of Isabela and Two (2) Regional Trial Courts in Metro Manila.


#### b. Delivery of Insular Prisoners:


For the period, this Jail shipped a total of Four (4) Insular Prisoners to National Bilibid Prison (NBP) Muntinlupa City and One (1) Insular Prisoner to Correctional Institution for Women last February 2020. These Insular Prisoners will served their respective Sentences thereat.














**Fig. 1-** Photograph showing **four (4)** Insular Prisoners committed at National Bilibid Prison Muntinlupa City. (From Left to right) 1. Jeffrey Vidal; 2. Dominador Balagat; 3. Dimas Vargas; 4. Erwinson Frogoso and **one (1)** Insular Prisoner to Correctional Institution for Women 1. Rosemarie Regarde last February 2020.

#### c. Commitment of Prisoners:

For the period, a total of **Two Hundred Sixteen (216)** inmates/PDLs or an **average of Eighteen (18)** inmates per month were committed and received in this Jail charged with various offenses and emanates from the different Regional Trial Courts in the province of Isabela.

#### d. Decongestion of Prisoners:

For the period, a total of **One Hundred Seventy Five (175)** inmates/PDLs or an average of **Fourteen (14)** inmates/PDLs per month were released/discharged from the custody of this jail by virtue of a Court Order.

## **II. SECONDARY**

#### a. Health Program

For the period, **Two Thousand Five Hundred Forty (2,540)** inmates/PDLs or an average of **Two Hundred Eleven (211)** inmates/PDLs per month were taken Blood Pressure.

A total of **Two Thousand Seventy-five (2,075)** inmates/PDLs or an average of **One Hundred Seventy-two (172)** inmates/PDLs per month were recipient of assorted medicines/capsules/vitamins.

A total of **Thirty (30)** inmates/PDLs or an average of **Two (2)** inmates/PDLs per month were recipient of First Aid.

A total of **Twenty-four (24)** inmates/PDLs or an average of **Two (2)** inmates/PDLs per month were brought to Gov. Faustino N. Dy Sr. Memorial Hospital, City of llagan, Isabela for treatment of various sickness/illness and some were confined with proper escort.

#### b. Clean and Green Livelihood Program:

For the period, inmates/PDLs clean and green program is being undertaken by way of planting different vegetables as their livelihood program, while other inmates/PDL were involved in handy craft projects like basket, table and picture frame weaving, using cogon as their major materials, others were involved in backyard poultry and piggery projects. The maintenance of these projects is being supervised by IPJ personnel.






Fig. 2 - Photograph showing finish products of Cogon. Table, stool, back pack and fruit tray crafting.




Fig. 7 - Photograph showing the Tower 2 guard house of Isabela Provincial Jail.








Fig. 11 - Photograph showing Ilagan City Police Station conducting Oplan Galugad headed by Lieutenant Colonel Virgilio Vicon M. Abellera Jr. wherein the operation resulted negative.






Fig. 13- Photograph showing IPJ personnel conducting Anti Disinfectant spray inside jail facility as per directive of the Provincial Governor last October 07, 2020.




Fig. 16 - Photograph showing Atty. Leonard Pua and Luisa Pua donated food to personnel, food and personal hygiene kit to PDL's of Isabela Provincial Jail as part of their family's thanksgiving every December last December 04, 2020.





Fig. 17 — Photograph showing (from left to right) contenders of the PDL's search for Mr. Pogi; female PDL's rendering their song number on the said event; Provincial Warden Sir Emelito M. Marquez giving awards and the runner's up and newly crowned Mr. Pogi 2020 held last December 21, 2020..




Fig. 19 - Photograph showing the on-going repainting of Isabela Provincial Jail building.






Fig. 20 — Photograph showing the 2 Certificate of Recognition awarded to Provincial Warden Emelito M. Marquez for being one of the Top 10 MOST OUTSTANDING PROVINCIAL JAIL EMPLOYEE of the PHILIPPINES and to Isabela Provincial Jail for being one of the top 10 BEST MANAGED PROVINCIAL JAIL in the Philippines.
