Annual Accomplishment Report

January – December 2024

SUMMARY

Submitted herewith is the Annual Accomplishment Report of Isabela Provincial Jail covering the period from January 1, 2024 to December 31, 2024. Total number of Person Deprived of Liberty (PDL) is 197 as of December 31, 2024.

I. PRIMARY:

a. Inmates/PDLs Escort and Security:

For the period, a total of **One Thousand Six Hundred Nine (1,609) PDLs/Inmate's** or an average of **One Hundred Thirty-Four (134) PDLs/Inmates** per month were escorted and secured while attending Court hearings in face to face and thru videoconference in Twelve (12) Regional Trial Courts; One (1) Municipal Trial Courts in Cities (MTCC) and Seven (7) Municipal Circuit Trial Courts in the Province of Isabela.

b. Delivery of Insular Prisoners:

For the period, this Jail transferred **Nine (9) Insular Prisoners** to National Bilibid Prison (NBP) Muntinlupa last February 9, 2024 and another **Four (4) Insular Prisoners** on September 27, 2024. These Insular Prisoners will serve their respective Sentences thereat.

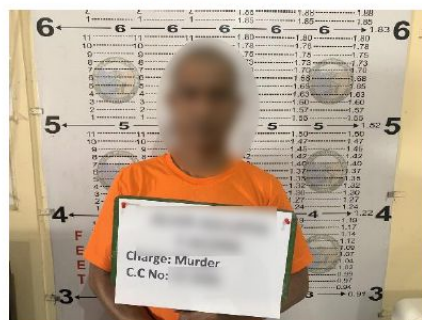




Fig. 1- Photograph showing the **nine (9)** Insular Prisoners committed at National Bilibid Prison Muntinlupa City on February 9, 2024. 1. [redacted]; 2. [redacted]; 3. [redacted]; 4. [redacted]; 5. [redacted]; 6. [redacted]; 7. [redacted]; 8. [redacted] and 9. [redacted].

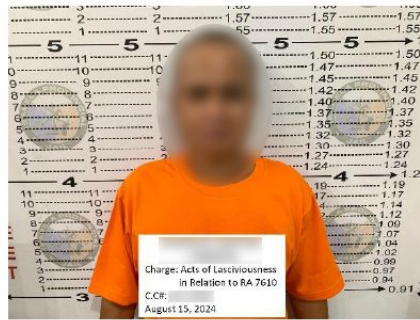




Fig. 2- Photograph showing the **four (4)** Insular Prisoners committed at National Bilibid Prison Muntinlupa City on September 27, 2024. 1.

c. Commitment of Prisoners:

For the period, a total of **One Hundred Sixty-Six (166)** PDLs/Inmates or an **average of Fourteen (14)** PDLs/Inmates per month were committed and received in this Jail charged with various offenses and coming from the different Regional Trial Courts in the province of Isabela.

d. Decongestion of Prisoners:

For the period, a total of **One Hundred Seventy-Three (173)** PDLs/Inmates or an average of **Fourteen (14)** PDLs/Inmates per month were released/discharged from the custody of this jail by virtue of Court Order.

II. SECONDARY

a. Health Program

For the period, **Two Thousand Four Hundred Three (2,403)** PDLs/Inmates or an average of **Two Hundred (200)** PDLs/Inmates per month were beneficiaries/recipient of Blood Pressure checking.

A total of **Three Hundred Seventy-One (371)** PDLs/Inmates or an average of **Thirty-One (31)** PDLs/Inmates per month were recipient of assorted medicines/capsules/vitamins.

A total of **Six (6)** PDLs/Inmates or an average of **One (1)** PDL/Inmate a month were recipient of First Aid.

A total of **Twelve (12)** PDLs/Inmates or an average of **One (1)** PDL/Inmate a month were brought to Gov. Faustino N. Dy Sr. Memorial Hospital, City of Ilagan, Isabela for treatment of various sickness/illness and some were confined with proper escort.

b. Clean and Green Livelihood Program:

For the period, PDLs/Inmates clean and green program is being undertaken by way of planting different vegetables as their livelihood program, while other PDLs/Inmates were involved in handy craft projects like basket, table and picture frame making, using cogon as their major materials, others were involved in backyard poultry and piggery projects. The maintenance of these projects is being supervised by IPJ personnel.

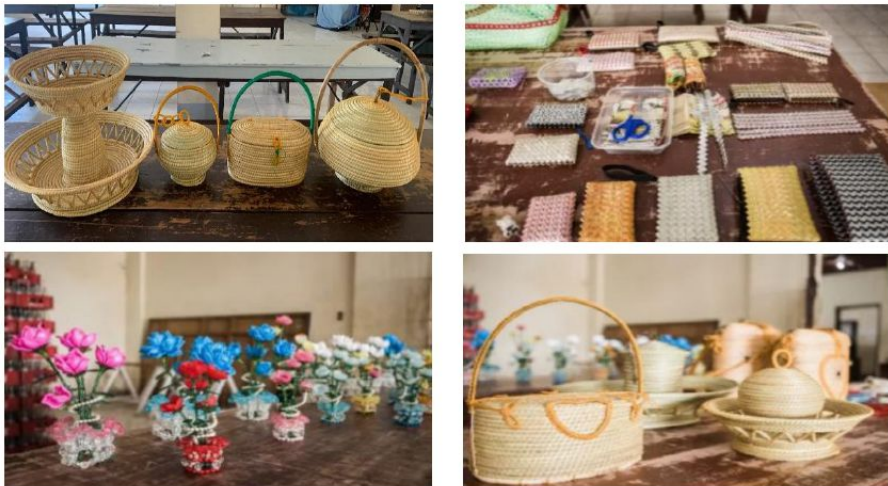


Fig. 3- Photograph showing finished product of handy craft project made of COGON AND RECYCLED materials.

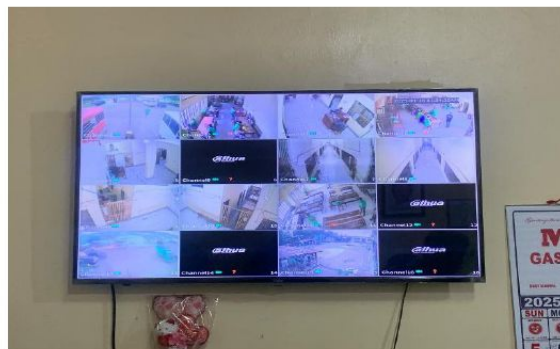


Fig. 10- Photograph showing the 16 capacity CCTV monitor of the Isabela Provincial Jail

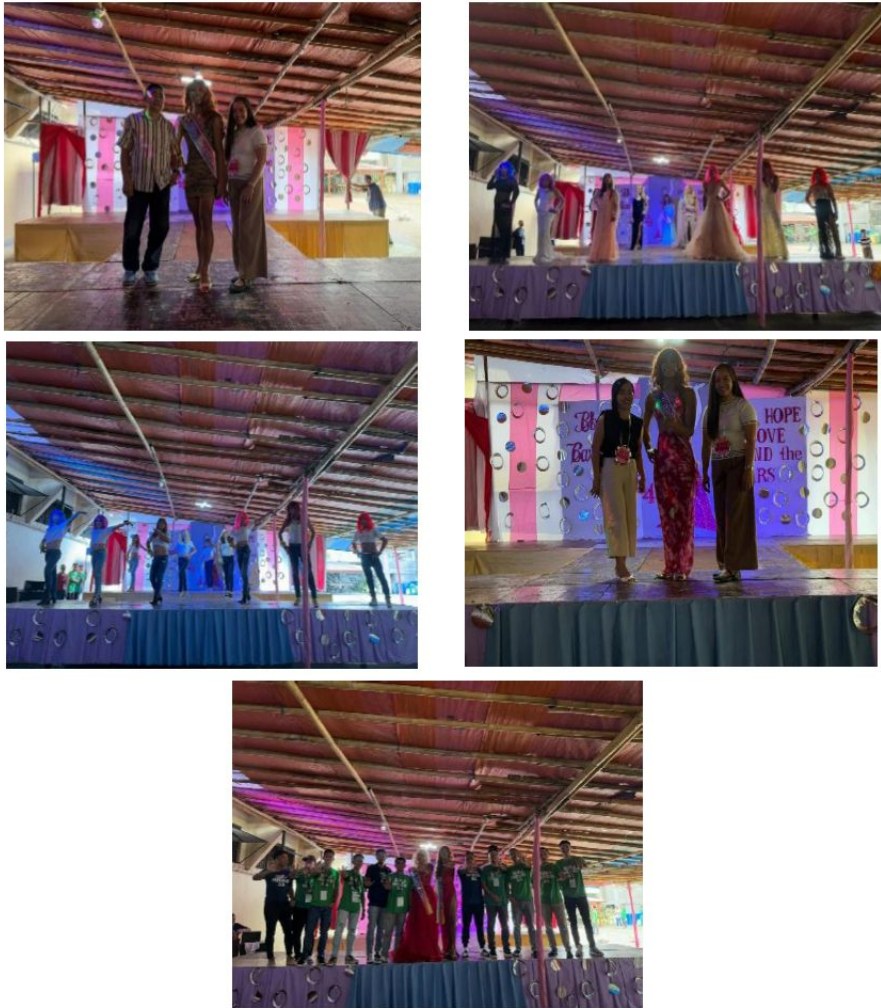


Fig. 36- Photograph showing the Isabela Provincial Jail Person Deprived of Liberty (PDL) conducted “Binibining Barako” as they celebrated their Christmas Program on December 22, 2024.
