1.	Local Road Network and Development Plan	The LRNDP is an integrated 5-year development plan for the sustainable development and maintenance of local road networks.	Participated in the two-day consultative workshop held on August 12-13, 2021 for the enhancement of the LRNDP.  The enhanced Plan was presented to the Provincial Development Council (PDC) during the 4 <sup>th</sup> Quarter Regular Business Meeting of the PDC-PPOC-ELCAC-IPTF-PDRRMC held on October 20, 2021.  The PDC favorably endorsed the said Plan to the Sangguniang Panlalawigan for their approval.
2.	Devolution Transition Plan	In line with the implementation of the SC Ruling, Presidential Executive Order (EO) No. 138, s. 2021 orders the full devolution of functions, services, and facilities by the national government to the LGUs not later than the end of FY 2024.  To support transition to full devolution, all LGUs are to formulate and prepare Devolution Transition Plans (DTPs) to guide the transition in the full assumption of the devolved roles and responsibilities	All devolution-affected members were requested to submit names of focal persons that would form part of the Technical Working Group.  The PPDC spearheaded the conduct of the two-day orientation-workshop held on August 26-27, 2021 in preparation for the formulation of the Devolution Transition Plan (DTP).  Staff of the PPDO walked through the process of filling-out the required templates for the DTP.
3.	Balik Probinsya, Balik Pag-asa (BP <sup>2</sup> ) Program	A flagship program of the national government that aims to bring home disadvantaged Filipinos from the urban centers to the provinces by accelerating regional development towards the improvement of the quality of rural life.  The province was chosen as one of the pilot areas for initial implementation.	Continuous monitoring of the provision of restart packages under the Isabela Reintegration and Transformation Approach (IRTA).

Search for the Most Business Friendly LGU 2021	An annual search spearheaded by the Philippine Chamber of Commerce and Industry (PCCI) to commend LGUs that have successfully enhanced or instituted an environment that is conducive to business.  This year's initiative aims to highlight success stories and best practices of LGUs in addressing the negative impact of the pandemic to the business community.
