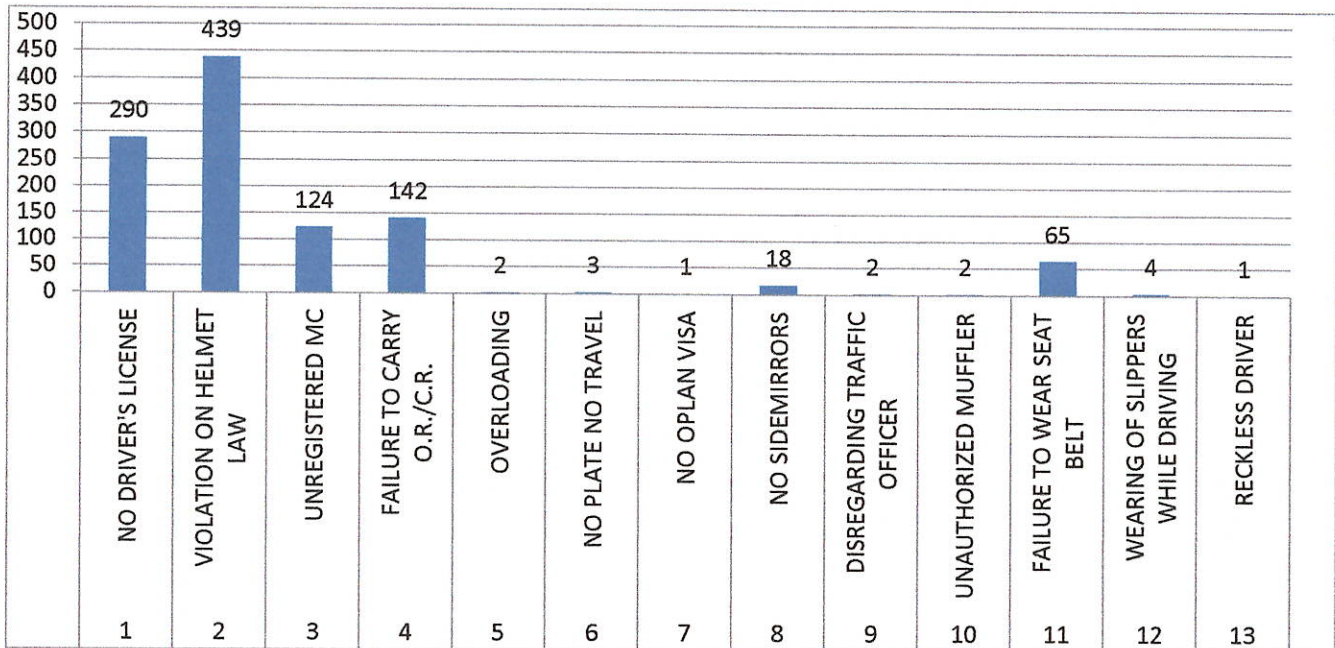
### . OPERATION:
