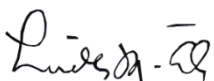

	<b>Spiritual Services and Values Inculcation</b>	<ul style="list-style-type: none"> <li>• Provision of spiritual enhancement to all children through group prayer, morning worship, and Bible sharing inculcated by the staff and religious group (Victory).</li> <li>• Every child was motivated to lead the prayer during meal time as part of spiritual teaching.</li> <li>• Conducted monthly character building session to all residents for values formation.</li> </ul>
