Women and Children Protection Center	Home Life Services	<ul style="list-style-type: none"> Provision temporary shelter and protective custody to 22 admitted clients. Activity on backyard gardening was introduced to all residents to become self-reliant. All admitted residents have accorded with basic needs like food, clothing, toiletries, and other essential needs charged to MOOE. All residents have guided in daily life experience like managing personal hygiene, self-care and light chores as part of home life activities. Conducted monthly meeting with the residents and able to addressed their issues and concerns. Conducted monthly character building to all the residents and choose the best performer among residents to boost moral values and recognized work life experience in the center. 	Psycho-Social Care Services	<ul style="list-style-type: none"> Psychometrician, Ms. Alliana Dawn Salmos and Ms. Alyssa Mary Ballesteros conducted two (2) sessions on group dynamics to all residents (except the babies) for them to improve speaking & writing skills and gain self-confidence, also to improve grammar and vocabularies in connection/preparation to testify in the court. One (1) client was diagnosed to have Post Traumatic Stress Disorder (PTSD) who underwent follow-up checkup to a Psychiatrist, Doc. Ethel Maureen Pagaddu. Provision of free medicines for 35 days was provided. Small talked & individual counseling to three (3) clients was provided to them to enhance coping skills and improve relationships, conducted by the Social Workers and Psychometricians. Group counseling was accorded to five (5) clients to improve anger management skills and emotional regulation, conducted by the Mental Health Practitioners. 																		
	Educational Services	<ul style="list-style-type: none"> This month, house parents and other staff conducted tutorial activity to those residents who are slow reader. Separate tutorial activity on basic writing to two clients having intellectual disability. 																		

	Health Services	<ul style="list-style-type: none"> • One (1) resident's baby was admitted at the FNNDM Hospital due to Gastro Enteritis and availed for free laboratory, medicines, and confinement at the GFNDM Hospital. • Two (2) clients were brought to the FNNDM Hospital - Surgery & ENT Department for medical checkup due to lump (below the chin & breast). They were advised for submental and breast ultrasound for further evaluation. • One (1) client was referred for dental checkup due to tooth ache. • One (1) client was brought to a Psychiatrist for follow-up checkup with provision of free medicines. • In-house Nurse regularly examined physical & hygiene of every resident including height and weight for health monitoring. • In-house Nurse, Ms. Lady Vanessa Lagasca conducted health activity: Stage Play, for health awareness and improvement of self-esteem of every resident.
	Legal Services	<ul style="list-style-type: none"> • There are two (2) clients whose criminal complaints were promulgated with a decision of reclusion perpetua at the Regional Trial Court of Br. 21 Family Court, Santiago City & Br. 23 Cabagan Court. • Two clients (2) were escorted at the RTC Br. 18 & 23 for arraignment and pre-trial relative to their filed criminal complaints. • Two (2) clients were assisted for briefing of sworn statement in preparation for direct examination at the RTC Br. 23.
	Spiritual Services and Values Inculcation	<ul style="list-style-type: none"> • Thanksgiving activity through Holy Mass Celebration presided by Rev. Father Mel Alcala was conducted inside the Center for continuous spiritual growth of all residents and staff. • Film viewing was also provided to all residents for values inculcation. • Conducted monthly character building session to all residents for continuous values formation.
	Recreational, Sports and other Socio-Cultural Activities	<ul style="list-style-type: none"> • Children were given privilege in watching television as part of recreational activity, with closed supervision from the house parents. • Given free time for sports activity like volleyball, badminton, touching ball for physical development and camaraderie of all residents. • Provision of scrabble and other table games were provided to all resident for physical and mental growth. • Celebration of birthday of residents for the month of June with provision favored food and surprised debut program for one of the residents.
	Economic/ Livelihood Skills and Development	<ul style="list-style-type: none"> • For this month, the Center introduced basic sewing to nineteen (19) residents for them to become productive this school/summer vacation. Each client will be guided to cut and sew their own bed sheets and pillow case for enhancement of their skills with the help of house parents. • Nineteen (19) residents have undergone free training on "Utilization of Weeds as Source of Livelihood"----- • Continuous livelihood income generating activity for the young adult children for inculcation of profit sharing and retention of learning.
	Financial Assistance	<ul style="list-style-type: none"> • One (1) adult client was discharged from the Center for independent living and availed of financial assistance from the PGI and DSWD-SWAD Office for latter's basic/personal needs. • Provision of financial assistance for transportation allowance/fare in going back home for residents' parents & relatives who came to visit their respective children.
	Case Management	<ul style="list-style-type: none"> • Updating of case folder of twenty three (23) admitted children with Case Study Report, Intervention Plan, Running Notes, Monthly Anecdotal Report, Medical Record, Daily Observation Logbook, and other records.

		<ul style="list-style-type: none"> This month, convened two (2) case conference & discharge conference of clients together with the referring party & other members of the rehabilitation team to come-up with another six months Intervention Plan and After Care Plan of an adult client for independent living.
