At the end of the month, the house parents/staff will choose the best performer among the residents to boost moral values and confidence.

	Psycho-Social Care Services	- Assisted client at the OJ Fortune Psychological Services for her 3rd session of psychological interview. The result will be the basis of rehabilitation team to prepare & implement intervention plan for possible healing & recovery of the client. - There are four clients were provided with individual counseling who have encountered symptoms of PTSD likewise in preparation for their court appearance, conducted by the Mental Health Professionals (MHP) Ms. Alliana Dawn Salmos, Psychologist and Ms. Alyssa Mary Ballesteros, Psychometrician. - Group counseling was provided to six clients who encountered anxiety, reticent, and other manifestation of PTSD. This activity somehow provides support system, promoting therapeutic environment, and develop the skills and strategies to overcome challenges in life.																					

	Educational Services	• For children's safety and protection, the House parents regularly assisted/fetched the children in the school who are attending face to face class (elementary) likewise, assisted those children enrolled in secondary in submitting answered modules. • The house parents regularly attended Brigada Eskwela as well as meeting in preparation for the 1st Communion of two (2) children. • All learners/in-school children were guided by the Houseparents in complying school projects, answering modules including research work. • All residents enrolled in formal education & ALS were provided with school supplies, allowance/fare, projects and other mandatory contributions. • The Center Head and Houseparents continuously collaborate with the Class Advisers/Teachers & Principals to address other issues and concerns of in-school children. • For additional learning, all children were participated in Project Wellness Activity conducted by the ISU Ilagan Campus female personnel.
	Health Services	• There are two clients were provided with dental services (tooth extraction and dental filling) with provision of free medicines. • One client was administered with deworming pills to help improves health and nutrition aspect. • Three (3) clients were isolated in the Infirmary Room due to cough and colds with provision of free medicines. Observation and monitoring were also done by the In-House Nurse and house parents. • Continuous provision of medicines was provided to all residents who experienced cough, colds, and fever. Likewise, multi-vitamins/vitamin C administered to them to boost immune system. • Monthly checking of height and weight of all residents was also part of medical and physical activities of the In-House Nurse for purpose of health monitoring by using the Body Mass Index (BMI) Chart. • At least twice a month, the In-House Nurse was continuously provided health sessions among the residents through discussion on "Health Stroke" and "Proper Hygiene specifically Body Odor" for the purpose of health promotion and habitually maintain proper hygiene.
	Legal Services	• At the Regional Trial Court Br. 21 - Family Court in Santiago City, one client was able to attain justice with promulgation of Reclusion Temporal and Reclusion Perpetua for the two filed criminal complaints against the perpetrator. • There are nine (9) clients were assisted and escorted for direct & cross examinations, and arraignment at the Regional Trial Court Branch of 16, 17, 18, 19, 23, & 24. • There are four (4) clients were presented and assisted to the Prosecutors for briefing of sworn statement prior to the scheduled hearing and appearance to testify in the court. • Consultation with Prosecutor [REDACTED] was made last March 3, relative to the case of two clients.
	Spiritual Services and Values Inculcation	• Holy Mass celebration was conducted last March 3, 2025 as part of the kick-off activity of National Women's Month presided by Fr. Tim. On March 28, 2025, another Holy Mass was celebrated in the Center officiated Fr. Mel wherein all

		children have attended regardless of their religion for their spiritual growth. • There are eight (8) children who undergone catechism/lecture prior to baptism ceremony, conducted by Ms. Gertrudes Awingan (Catechist) of the Diocese of Ilagan. • Provision of baptism or christening ceremony to eight (8) children sanctified by Fr. Tim. It symbolizes spiritual cleansing and rebirth in Christian faith. Likewise, this is one of the seven sacraments in the Catholic Church and a privilege given to the children who deprived to be baptized. • There are two (2) clients who have undergone first communion, a significant sacrament in the Catholic Church. • All residents were guided in daily life experienced through group prayer and devotion every morning and evening regardless of their religion. Also, they are motivated to lead the prayer before and after mealtime as part of spiritual teaching.
	Recreational, Sports and other Socio-Cultural Activities	• Through mobilizing GAD Fund, the Center was able to celebrate the special event on National Women's Month that pays tribute to the exemptional roles of every Juana's in the society especially women and children in difficult circumstances as heralds of change and women empowerment. This special event was celebrated last March 20, 2025 highlighted with two (2) genres for individual and group contests on Spoken Poetry and Drama Ni Juana. This activity encouraged every resident/young woman to know/be aware on their rights and discover their inner talents & skills and by regaining self-esteem and confidence. • All residents were given opportunity to go to the Queen Isabela Park for their Zumba activity and free play. Likewise, expressing of emotions through singing (videoke) and dancing as part of their psychosocial therapy inside the Center. • In the observance of Fire Prevention Month, the Center in coordination with the Bureau of Fire Prevention (BFP) Provincial Office joints in the celebration through the conduct of training/lectures on Orientation on Fire Safety Awareness and Basic Fire Safety Drill for the residents and staff last March 12, 2025.
	Economic/ Livelihood Skills and Development	• Provision of free skills training on meat processing was provided by the TESDA trainers to all residents and staff. This activity somehow helped the residents acquire and enhance new skills, knowledge, & performance and discover their line of interest for income generating/livelihood.
	Case Management	• Pre-discharged conference was convened last March 14 together with Mrs. Clarita Camello, SWO-II of MSWDO Cordon, Isabela, biological mother and auntie of two (2) clients due for discharge this coming May or June. Submission of PCAR will be on April 23, 2025. • Conducted home visit and case conference in Penablanca, Cagayan together with SWO-II Ms. Glorina Cristobal relative to discharged client last February, 2025. • Regular updating of case folder of 17 admitted children with Case Study Report, Intervention Plan, Running Notes, Monthly Anecdotal Report, Medical Record, Daily Observation Logbook, and other records are continually updated and properly filed. • Attended court proceedings and other legal activities of every
