# **EXPLANATORY NOTE**

WHEREAS, on March 2016, the Provincial Government of Isabela passed the Isabela Youth Welfare and Development Code acknowledging therein the important role of the youth in nation-building by recognizing their right to representation in the formulation of the policies of the Provincial Government, promoting their political, civil, social, and economic rights, recognizing the plight of young parents and the financially-disadvantaged, and providing them with necessary and age-appropriate assistance;

WHEREAS, Vice Governor, Hon. Faustino G. Dy III, initiated a review of the said Ordinance and ascertained that there is a need to introduce amendments thereto particularly the strengthening of the Isabela Youth Development Council, providing the youth who push for faith, cultural, and other special advocacies with representation, prioritizing their development by the provision of specialized education, seminars, and trainings, and providing them with other privileges as provided below,

WHEREAS, in this light, Hon. Dax Paolo C. Binag, Chairperson of the Committee on Sports and Youth Development, and Hon. Abegail V. Sable, author of the original ordinance, spearheaded the formulation, drafting, and proposal of amendments, with

SECTION 1. Section 2 of Ordinance No. 02, Series of 2016 titled ""AN ORDINANCE PROVIDING FOR A COMPREHENSIVE CODE FOR THE YOUTH IN THE PROVINCE OF ISABELA AND OTHER PURPOSES AND PROVIDING FUNDS THERETO" which reads:

"SECTION 2. POLICY – The State recognizes the vital role of the youth in nation building and shall promote and protect their physical, moral, spiritual, intellectual, and social well-being. It shall inculcate in the youth patriotism and nationalism, and encourage their involvement in public and civic affairs."

is hereby amended to read as follows

#### "SECTION 2. - DECLARATION OF POLICY.

- a) The Provincial Government of Isabela adheres to the policy of the State in recognizing the role of the youth in nation-building and in the promotion and protection of their physical, moral, spiritual, intellectual, and social being. As such, it shall inculcate in the youth patriotism and nationalism, and encourage their involvement in public and civic affairs.
- (b) The Provincial Government of Isabela shall ensure the participation of the youth in its decision-making process on the resolution of various issues concerning the youth;
- (c) The Provincial Government of Isabela shall ensure that the rights of the youth are well protected and enforced at all times, and that the entirety of the Province of Isabela, including all workplaces and institutions, is conducive to learning and education.

- (d) The Provincial Government of Isabela shall ensure that the youth is provided with adequate assistance and aid to guarantee them of a good and productive future.
- (e) The Provincial Government of Isabela shall ensure the regular conduct of programs aimed at developing the skills and improving the competence of the youth.

#### **SECTION 2:** Section 4 of the same Ordinance which reads:

#### **SECTION 4. DEFINITION OF TERMS.**

- (a) YOUTH by virtue of Republic Act 8044 otherwise known as the Youth in Nation-Building Act of 1995, and for the purpose of this Ordinance, shall refer to those persons whose ages ranges fifteen (15) to thirty (30) years old, which shall include but not limited to the following: Sangguniang Kabataan Members, Isabela Province Youth Officials, Youth Organizations, Student Council Organizations, Out-of-School Youth (OSYs), and all other youth organizations duly organized in the community.
- (b) **YOUTH** as defined in this code shall refer to 15 to 40 years old (UN DECLARATION)
- (c) **YOUTH OF SCHOOL AGE** shall refer to all youth whose ages range from 15-25 years:
- (d) MINOR YOUTH shall include all youth whose ages range from 15-17 years;
- (e) **WORKING YOUTH** shall refer to all youth whose ages range from 18-30 years who are employed either on a regular or temporary basis.
- (f) OUT-OF-SCHOOL YOUTH shall refer to all youth of school age, whether organized or not, who are unable to avail of the formal school system or who have dropped out from formal elementary and secondary education.
- (g) IN-SCHOOL YOUTH refers to all youth of school age, whether organized or not, presently enrolled with any educational, vocational institution which include but not limited to the following school organizations ( academic or non-academic ), student government, fraternities and sororities.
- (h) SPECIAL YOUTH refers to youth with disabilities or those suffered physical defects, as well as youth with special needs which include but not limited to those who are drug dependents, in conflict with the law and those caught in armed conflicts.
- (i) COMMUNITY YOUTH ORGANIZATIONS are organizations whose majority of membership are youth and might be based in educational institution but whose program are not solely for educational advancement or may be community-based whose members are not all out-of-school youth.
- (j) CIVIL RIGHTS are those rights of the youth to be protected against all forms of abuse, exploitation and discrimination in situations where the youth is considered in extremely difficult circumstance.

- (k) ECONOMIC, SOCIAL, AND CULTURAL RIGHTS pertain to the access of the youth to educational opportunities, relevant information, leisure, cultural activities and the right to freedom of thought, conscience and religion.
- (I) **POLITICAL RIGHTS** are those rights which provides the youth the freedom to express themselves on matters affecting their lives.
- (m) ANTI- SOCIAL RELATED ACTIVITES are those acts against property, chastity and person which include but are not limited to the following:
  - 1. Petty crimes such as snatching, shoplifting, misrepresentations;
  - 2. Using and pushing of prohibited drugs;
  - 3. Selling or distribution of lewd/obscene reading materials;
  - 4. Pimping for young and adult prostitutes, sexual perversions and doing or participating in obscene shows;
  - 5. Gambling of any form;
  - 6. Rape and incest; and
  - 7. All other circumstances as defined in the existing laws.
- (n) HAZING shall mean an initiation rites being conducted as a prerequisite for admission as member in a fraternity, sorority, or organization by placing the recruit, neophyte, or applicant in an embarrassing or humiliating situation such as forcing him/her to do menial, silly foolish, and other similar tasks or activities, or otherwise subjecting him/her to physical suffering or injury.

is hereby amended to read as follows:

(a) Youth shall refer to all persons aged fifteen (15) to thirty (30) years old. For purpose of targeted programming for the youth, the following age disaggregation shall be considered:

15 – 17 – child youth

15 – 25 – youth of school age

18 – 24 – core youth

25 – 30 – adult youth

- (b) Special Advocacy-Based Youth shall refer to any youth organization whose primary purpose is to serve and represent the youth with particular needs, namely: youth with disabilities, youth in situations of armed conflict, victims of natural disaster and calamities, youth offenders, youth in conflict with the law, youth-member of the LGBTQ community, youth with drug dependencies, youth victims of abuse or exploitation, or those abandoned;
- (c) COMMUNITY-BASED YOUTH shall refer to a youth organization based on a particular barangay, whose membership consists of youth residing in the same barangay, and whose advocacy centers on serving the youth in that particular area;
- (d) THE CULTURAL IDENTITY-BASED YOUTH shall refer to youth organizations whose primary purpose is to advance the cultural identity of the Province Isabela and its indigenous people;

- (e) FAITH-BASED YOUTH shall refer to a youth organization organized under the rules and regulations of a religious institution and recognized as such;
- (h) **SOCIAL DEVIATIONS** are those acts against property, chastity and person which include but are not limited to the following:
  - 1. Petty crimes such as snatching, shoplifting, misrepresentations;
  - 2. Using and pushing of prohibited drugs;
  - 3. Selling or distribution of lewd/obscene reading materials;
  - 4. Pimping for young and adult prostitutes, sexual perversions and doing or participating in obscene shows;
  - 5. Gambling of any form;
  - 6. Rape and incest; and
  - 7. All other circumstances as defined in the existing laws.
- (j) YOUTH WITH PROBLEMS. Any individual falling under the youth age who is a victim of or is experiencing social or mental difficulties such as, among others: teenage pregnancy; alcohol and substance abuse; prostitution; sexually transmitted infections; bullying; physical and emotional abuse inflicted within the home; substance abuse; or vagrancy.
- (k) **YOUTH ORGANIZATIONS** shall refer to those organizations whose membership or composition are youth.
- (I)YOUTH-SERVING ORGANIZATIONS shall refer to those organizations whose principal programs, projects and activities are youth-oriented and youth-related, and whose composition are not limited to the youth. The organization shall be duly-recognized or accredited either by the PGI or the National Youth Commission.

## SECTION 3. Section 7 of the same Ordinance which reads:

# SECTION 7. – COMPOSITION OF THE ISABELA COUNCIL FOR YOUTH DEVELOPMENT. The ICYD shall adopt the following composition:

- a) The Provincial Governor and the Chairperson on Youth Affairs shall be automatic members of the council.
- b) All accredited youth organization shall be assembled through a congress and shall elect their **sectoral representatives**, **two (2) from each sector**:
  - 1. In-school youth
  - 2. Out-of-school youth
  - 3. Community Youth
- c) The **Provincial Chairperson on Youth Affairs** will automatically be the Chairperson of the Council, and from among the representatives of the elected sectoral representatives, shall elect the:
  - 1. Co-chairman/Vice-Chairman
  - Secretary
  - Treasurer

### "SECTION 7. - COMPOSITION OF THE ISABELA YOUTH DEVELOPMENT COUNCIL.

The Isabela Youth Development Council, hereinafter referred to as Council, shall be composed of the authorized representatives of all accredited Youth Organizations and Youth-Serving Organizations, which shall be not more than one (1) for each organization, within the Province of Isabela.

**SECTION 4.** A new section, designated as Section 7-A, is hereby inserted to read as follows:

"SECTION 7-A. The Council shall have its set of officers which shall be at least ten (10) but not more than twenty-one (21) the composition of which shall be as follows:

- a) The Sangguniang Kabataan (SK) Federation President, who shall be the Chairperson of the Council.
- b) The Sangguniang Kabataan (SK) Federation Vice President, who shall be the Vice Chairperson of the Council.
- c) Advocates. The following advocacies shall be provided with representation in the Council:
  - 1. Education:
  - Health;
  - Environment;
  - Religion;
  - Economic Empowerment;
  - Social Inclusion and Equity;
  - 7. Governance;
  - Active Citizenship;
  - 9. Culture and Tradition:
  - Global Mobility;
  - 11. Peace Building and Security; and
  - 12. Other advocacies as may be identified by the Council.

The **Provincial Youth Development Office** shall serve as the **Secretariat of the Council**, and as such shall execute the following objectives:

- i. to assist the Council in the performance of its duties and responsibilities;
- ii. to act as custodian and keeper of all Council documents and records;
- iii. to serve as coordinator between the Council and other institutions, public or private, and the general public on all matters pertaining to youth development."

**SECTION 4.** A new section, designated as Section 7-B, is hereby inserted to read as follows:

### "SECTION 7-B. QUALIFICATIONS OF A COUNCIL MEMBER.

An Officer of the Council must be: a citizen of the Philippines; a resident of the province for not less than one year immediately preceding the day of assumption as member of the Council; at least fifteen (15) years but not more than thirty (30) years of age on the day of assumption as member of the Council; a member of a duly accredited Youth Organization or Youth-Serving Organization; able to read and write Filipino, English, or any local dialect in the Province of Isabela; and must not have been convicted by final judgment of any crime involving moral turpitude.

**SECTION 5.** A new section, designated as Section 7-C, is hereby inserted to read as follows:

#### "SECTION 7-C. MANNER OF ELECTION OF COUNCIL OFFICERS.

Within forty five (45) days after the SK elections, the PYDO shall notify all the presidents or authorized representatives of the registered youth organizations or youth serving organizations in the Province of Isabela, assemble them in a public venue, and by consensus or secret balloting, they shall elect at least eight (8) but not more than nineteen (19) advocates. The term for Advocate shall be for three (3) years, and must be a member of an organization which promotes the advocacy to which he or she will represent.

Local registration and verification of youth organization and youth serving organization is a condition precedent for participation in the Council elections."

**SECTION 6.** A new section, designated as Section 7-D, is hereby inserted to read as follows:

#### "SECTION 7-D. CONVENING OF THE COUNCIL.

The duly elected President or Vice President of the Panlalawigang Pederasyon ng mga SK shall automatically become members of the Council. The SK Pederasyon President, or in her/his absence, the Vice President shall convene the council and shall preside over all its meetings."

**SECTION 7.** A new section, designated as Section 7-E, is hereby inserted to read as follows:

# "SECTION 7-E. MEETINGS AND QUORUM.

i. The Council shall schedule a meeting every quarter, and as often as needed. However, if the Chairperson or the Vice Chairperson fails to convene the Council as scheduled, at least one-third of the total membership of the Council may call for a meeting. In both instances, a written notice shall be sent, either through traditional or non-traditional means, to all members setting the date, time, place and agenda of the meeting which must be received at least two (2) days in advance.

ii. The presence of the majority of all members of the Council shall constitute a quorum.

**SECTION 8.** Paragraphs 11, 12, 13, and 14 is hereby included in Section 8 of the same Ordinance which shall be read as follows:

- i. xxx
- k. Serve as a referring agency to the Provincial Social Welfare and Development and Provincial Youth Development Office concerning cases of youth with problems.
- To promote and publish information and studies on the youth, especially in the Province in all its aspects; and
- m. To coordinate with any department, division, office, or any instrumentality of the Provincial Government of Isabela or the National Government for such assistance as it may require in the performance of its functions.
- n. Perform such other functions as may be prescribed by law or ordinance."

**SECTION 9.** A new section, designated as Section 10-A, is hereby inserted to read as follows:

#### "SECTION 10-A. VACANCY IN OFFICE.

a) In case of permanent vacancy in the position of Chairperson, the SK Federation Vice President shall serve as Chairperson for the entire duration of the unexpired term.

In case of temporary vacancy, the Vice Chairperson of the Council shall serve as Chairperson until such time that the reason for the vacancy has ceased.

b) In case of permanent vacancy in the position of Vice Chairperson, the SK Federation Treasurer shall serve as Vice Chairperson for the entire duration of the unexpired term.

In case of temporary vacancy, the members of the Council shall elect from among themselves a temporary Vice Chairperson who shall serve as such until such time that the reason for the vacancy has ceased.

d) In the event of a permanent vacancy in the position of Advocate, the Youth Organization or Youth-Serving Organization in which the Advocate is a member shall nominate a substitute who shall serve as Advocate to the Council for the entire duration of the unexpired term. SECTION 10. Section 11 of the same Ordinance which reads:

**SECTION 11. -COMMITTEES AND THEIR RESPECTIVE DUTIES AND FUNCTIONS AND COMPOSITION.** The NCCYD shall create and adopt the following committees which shall perform oversee specific tasks of the council.

#### A. ADVISORY COMMITTEE

- a. An Advisory committee shall be created to supervise and monitor the operation of the ICYD.
- b. The main role of the Advisory committee is to review the following:
  - 1. The operation plan and budget of the council;
  - 2. Internal rules and procedure of the council;
- 3. Accreditation process and guidelines set forth by the accreditation committee.
  - c. The following are the members of the advisory committee.
    - Provincial Governor as chairperson
    - The Provincial Administrator
    - Provincial Planning and Development office (PPDO)
    - Provincial Social Welfare and development Office (PSWDO)
    - Provincial PESO (if available)
    - Education, Sports, and Scholarship Office (ESSO)

#### B. ACCREDITATION COMMITTEE

- a. An accreditation committee will be convened whenever necessary to act on all application for accreditation.
- b. The Accreditation committee shall be composed of the following:
  - SP Member who chairs the committee on Youth Affairs;
  - Representative belonging to the youth sector;
  - Representative from Education, Sports and Scholarship Committee;
  - Representative from the Provincial Social Welfare and Development Office;
  - Representative from the National Youth Commission (NYC)

is hereby amended to read as follows:

**SECTION 11. – CREATION OF COMMITTEES.** The PGI shall create the following committees which shall perform specific tasks aimed at ensuring that the provisions of this Code are complied with.
