

**PENDING ORDINANCES EMANATING FROM THE SANGGUNIANG
PANLALAWIGAN OF ISABELA IN CY 2017**

1. AN ORDINANCE ESTABLISHING A MECHANISM FOR THE PROVINCIAL IDENTIFICATION SYSTEM IN THE PROVINCE OF ISABELA, PROVIDING FOR BENEFITS AND RIGHTS AND CORRESPONDING OBLIGATIONS, AND FOR OTHER PURPOSES;
2. AN ORDINANCE REQUIRING ALL OWNERS OF BIG BUSINESS ESTABLISHMENT OPERATING AND DOING BUSINESS IN THE PROVINCE OF ISABELA, TO INSTALL A CLOSED CIRCUIT TELEVISION (CCTV) WITHIN THEIR PREMISES FOR SECURITY REASONS;
3. AN ORDINANCE PROHIBITING THE CONSTRUCTION OF ANY DWELLING STRUCTURES IN LOW LYING/FLOOD PRONE/LANDSLIDE AREAS WITHIN THE TERRITORIAL JURISDICTION OF THE PROVINCE OF ISABELA AND PROVIDING PENALTIES THEREOF;
4. AN ORDINANCE MANDATING ALL SLOW MOVING VEHICLES TRAVERSING THE TERRITORIAL JURISDICTION OF THE PROVINCE OF ISABELA TO USE ONLY THE OUTERMOST PORTION OF THE FOUR-LANE HIGHWAY OF THE NATIONAL AND PROVINCIAL ROAD;
5. AN ORDINANCE PROHIBITING ALL BUSINESS ESTABLISHMENTS IN THE PROVINCE OF ISABELA FROM ENCROACHING PORTIONS OF THE PROVINCIAL AND NATIONAL ROAD;
6. AN ORDINANCE APPROPRIATING FUNDS TO SUPPORT THE ESTABLISHMENT OF RIPARIAN BIO-DIVERSITY ECOSYSTEMS OF LOCAL GOVERNMENT UNITS IN THE PROVINCE OF ISABELA;
7. AN ORDINANCE APPROPRIATING FUNDS TO SUPPORT INDIGENT FARMERS IN TRANSITIONING TO ORGANIC AGRICULTURE;
8. AN ORDINANCE APPROPRIATING FUNDS FOR THE OPERATIONS AND MAINTENANCE OF ALE-ALE PERMACULTURE LEARNING RESOURCE CENTER TO SUPPORT THE PROMOTION OF ECOLOGICALLY-SOUND STRUCTURAL BUILDING, ORGANIC AGRICULTURE AND BIO-DIVERSITY CONSERVATION THROUGH THE ALE-ALE BAMBOO BUILDING, ORGANIC TRADING POST AND PERMACULTURE ECO-PARK;
9. AN ORDINANCE PROMULGATING POLICIES AND MEASURES FOR THE PREVENTION AND CONTROL OF STI/HIV/AIDS IN THE PROVINCE OF ISABELA, STRENGTHENING THE PROVINCIAL AIDS COUNCIL AND PROVIDING PENALTIES FOR VIOLATIONS THEREOF AND FOR OTHER PURPOSES;
