**EXECUTIVE ORDER NO. 48**

### ESTABLISHING THE ISABELA PROJECT IMPLEMENTATION TEAM OF THE PROVINCIAL GOVERNMENT FOR ALL PCF FUNDED PROJECTS

**WHEREAS**, it is the policy of the State to promote transparency, accountability, and the judicious use of resources in government;

**WHEREAS**, it is the policy of the Provincial Government of Isabela to uphold the governing principles of good financial housekeeping and transparency in the implementation of all government projects;

**WHEREAS**, the Provincial Government of Isabela supports economic development and ensure the efficient delivery of basic services in the entire province;

**WHEREAS**, Isabela is the recipient of numerous Performance Challenge Fund (PCF) incentives from the Department of Interior and Local Government (DILG) for being a consistent SGLG passer;

**WHEREAS**, in accordance with policy, there is a need to create a unit within the Provincial Government that will be responsible in monitoring the implementation of all PCF funded projects in the province;

**NOW THEREFORE, I, RODOLFO T. ALBANO III**, Governor of the Province of Isabela, by virtue of the powers vested in me by law, do hereby decree the following:

**Section 1. Creation.** There is hereby created the Isabela Performance Challenge Fund Project Implementation Team within the Provincial Government of Isabela that will be tasked to monitor the implementation of all PCF funded projects;

**Section 2: FUNCTIONS.** The Project Implementation Team shall have the following functions:

- a. Act as overall office-in-charge and oversight committee in the implementation of all PCF funded projects of the Provincial Government;
- b. Convene regularly to perform planning, program management and implementation, monitoring, evaluation, and coordinative functions relative to all PCF funded projects of the Provincial Government;
- c. Ensure the effective and successful implementation of all PCF funded projects of the Provincial Government;
- d. Recommend for the Governor's approval changes, amendments, and Measures for the improved implementation of the PCF funded projects;
- e. Furnish the Office of the Governor copies of any and all reports or important documents pertinent to the PCF funded project implementation ;



- f. Serve as the link between the Provincial Local Government of Isabela and the Contractors on all matters pertaining to PCF funded project contracts;
- g. Perform such other functions as may be necessary to meet the objectives of this Order.

**Section 3. Composition.** The Provincial Monitoring Unit shall be composed of the following:

**Section 4. FUNDING.** The funding requirements for the operations of the Project Implementation Team shall be sourced from Funds allocated for the Office of the Governor, subject to the usual budget, accounting, and auditing rules and regulations.

**Section 5. REPEALING CLAUSE,** All Orders, circulars, memoranda, rules, regulations, and other issuances or parts thereof that are inconsistent herewith are hereby repealed, modified, or amended accordingly.

**Section 6. SEPARABILITY.** If any part or provision of this Executive Order is held invalid or unconstitutional, other provisions not affected thereof shall remain in full force and effect.

**Section 7. EFFECTIVITY.** This Executive Order shall take effect immediately.
