EXECUTIVE ORDER NO. 02 - 2019

ORGANIZING A PROVINCIAL MONITORING TEAM TO ASSESS AND EVALUATE THE IMPLEMENTATION OF LOCAL ORDINANCES

WHEREAS, it is the policy of the State to ensure the accountability of local government units through the institution of effective mechanisms of recall, initiative and referendum;

WHEREAS, DILG Regional Memorandum Circular No. 2019-06 directs all LGUs to organize monitoring and evaluation teams that will assess the extent of implementation of ordinances;

WHEREAS, the Monitoring Team shall conduct an analysis of the results of the monitoring and submit the results of the monitoring and evaluation to the DILG ;

WHEREAS, there is a need to organize a Provincial Monitoring Team for Isabela to be in charge of assessing the extent of the implementation of ordinances in the cities and municipalities of the province;

NOW THEREFORE, I, RODOLFO T. ALBANO III, Governor of the Province of Isabela, by the powers vested in me by law, do hereby decree the following:

Section 1. Organization. There shall be organized a Provincial Monitoring Team for Ordinances in the province of Isabela;

Section 2. Functions. The Monitoring Team shall perform the following functions:

- a. Conduct an inventory of all existing ordinances of each city and municipality from January 1992 up to January 2018, using the prescribed form;
- b. Gather data relative to the implementation of the ordinances using the DILG-prescribed template ;
- c. Prepare a Report that will include Findings, Analysis, and Recommendations;
- d. Submit Report with accomplished monitoring forms to DILG cluster heads through the Provincial Director, for review;
- e. Ensure the presentation of the Report to all concerned LGU officials and functionaries;

- f. Perform other tasks as may be necessary in the effective implementation of this Order.

Section 3. COMPOSITION. The Ordinance Monitoring Team shall be composed of the following:

Vice Governor

MEMBERS : ALL DEPARTMENT HEADS
MEMBERS of The Sangguniang Panlalawigan
The Provincial Director, DILG

Section 4. TECHNICAL WORKING GROUP. A Technical Working Group (TWG) is also hereby organized to assist the Monitoring Team in data gathering, report writing/preparation and other related tasks, and shall be constituted as follows:

Head : Atty. Francis James Meer
Secretary to the Sangguniang Panlalawigan

Members: At least three (3) Personnel from Executive & Legislative
Offices of the Provincial Government



The TWG Head shall be responsible in accomplishing Form 1, the Inventory of Existing Teams that Monitor the Implementation of Ordinances.

Section 5. FUNDING. The funding requirements for the operations of the Ordinance Monitoring Team shall be sourced from Funds under the Office of the Governor, subject to the usual budget, accounting, and auditing rules and regulations.

Section 6. REPEALING CLAUSE, All Orders, circulars, memoranda, rules, regulations, and other issuances or parts thereof that are inconsistent herewith are hereby repealed, modified, or amended accordingly.

Section 7. EFFECTIVITY. This Executive Order shall take effect immediately.
