EXECUTIVE ORDER NO. 05

REORGANIZING THE PROVINCIAL PEACE AND ORDER COUNCIL OF THE PROVINCE OF ISABELA

WHEREAS, Section 116 of Republic Act no 7160, otherwise known as the " Local Government Code of 1991" provides for the organization of the local peace and order council to perform recommendatory and coordinative functions in support of the local government's peace and order campaign, and assist in policy formulation and implementation;;

WHEREAS, the change in the leadership of the province of Isabela after the elections of May 2019 and the separation, transfer and/or promotion from office of the members of the Provincial Peace and Order Council for the period July 2016 thru June 2019, have resulted in vacancies in the membership of the Isabela PPOC;

WHEREAS, there is a need to reconstitute the Council for the continuing effective implementation of the Peace and Order program and initiatives of the Provincial Government of Isabela;

The Provincial Office of the Department of the Interior and Local Government shall serve as the **PROVINCIAL PEACE AND ORDER COUNCIL (PPOC) SECRETARIAT** in-charge of handling the administrative and technical activities of the Council. Specifically, the Secretariat shall prepare policies, plans, programs, and projects for consideration of the Council; supervise, direct, and monitor the implementation of approved policies, plans, programs, and projects; undertake liaison and coordination activities with appropriate agencies of the government; and provide a forum for interdisciplinary dialogue and deliberation of major issues and problems affecting peace and order.

All Orders, circulars, memoranda, rules, regulations, and other issuances or parts thereof that are inconsistent herewith are hereby repealed, modified, or amended accordingly,

If any part or provision of this Executive Order is held invalid or unconstitutional, other provisions not affected thereof shall remain in full force and effect.

This Executive Order shall take effect immediately and let copies hereof be provided to the Council Members, the Sangguniang Panlalawigan, and all concerned for their information, reference, and guidance.,
