## EXECUTIVE ORDER NO. 06 - 2019

## REORGANIZING THE PROVINCIAL DISASTER RISK REDUCTION MANAGEMENT COUNCIL (PDRRMC)

WHEREAS, Republic Act 10121 otherwise known as AN ACT STRENGTHENING THE PHILIPPINE DISASTER RISK REDUCTION AND MANAGEMENT SYSTEM, PROVIDING FOR THE NATIONAL DISASTER RISK REDUCTION AND MANAGEMENT FRAMEWORK AND INSTITUTIONALIZING THE NATIONAL DISASTER RISK REDUCTION AND MANAGEMENT PLAN, APPROPRIATING FUNDS THEREFOR AND FOR OTHER PURPOSES, provides for the organization at the local governance level of the Provincial Disaster Risk Reduction and Management Council or PDRRMC;

WHEREAS, since its organization by virtue of an Executive Order issued by Governor Faustino G. Dy III, the PDRRMC of the province of Isabela has been exemplary and unmatched in its performance of its mandate to be at the forefront of all initiatives on disaster risk reduction and management (DRRM) in Isabela, as evidenced by its elevation to the Hall of Fame after bagging three championship awards as Gawad Kalasag Most Outstanding PDRRMC in the Philippines;

WHEREAS, the change in the leadership of the province of Isabela after the elections of May 2019 and the separation, transfer and/or promotion from office of the members of the Provincial DRRM Council for the period July 2016 thru June 2019, have resulted in vacancies in the membership of the Isabela PDRRMC;

WHEREAS, there is a need to reconstitute the Council for the continuing effective implementation of the DRRM program and initiatives of the Provincial Government of Isabela;

NOW THEREFORE, I, RODOLFO T. ALBANO III, Governor of the Province of Isabela, by powers vested in me by law, do hereby reconstitute the PDRRMC as follows:
