**EXECUTIVE ORDER NO. 07**

**REORGANIZING THE PROVINCIAL SCHOOL BOARD OF THE PROVINCE OF ISABELA**

**Whereas**, Republic Act 7160, other wise known as the Local Government Code of 1991, provides for the establishment of a Local School Board in every province, city, and municipality, a School Board;

**WHEREAS**, the change in the leadership of the province of Isabela after the elections of May 2019 and the separation, transfer and/or promotion from office of the members of the Provincial School Board, have resulted in vacancies in the membership of the Isabela PDRMC;

**WHEREAS**, there is a need to reconstitute the Provincial School Board for the continuing effective implementation of the education and youth development programs and initiatives of the Department of Education and the provincial government;

**NOW THEREFORE, I, RODOLFO T. ALBANO III**, Governor of the Province of Isabela, by the powers vested in me by law, do hereby reconstitute the Provincial School Board as follows:
