EXECUTIVE ORDER NO. 7-A - 2019

REORGANIZING THE PROVINCIAL HEALTH BOARD OF THE PROVINCE OF ISABELA

WHEREAS, SECTION 102 of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides for the creation and composition a local health board in every province, city, or municipality;

WHEREAS, the change in the leadership of the province of Isabela after the elections of May 2019 and the separation, transfer and/or promotion from office of the members of the Provincial Health Board for the period July 2016 thru June 2019, have resulted in vacancies in the membership of the Board;

WHEREAS, there is a need to reorganize the Provincial Health Board to ensure the continuity and responsiveness of the provincial government's health plans and programs for the people of Isabela;

NOW THEREFORE, I, RODOLFO T. ALBANO III, Governor of the Province of Isabela, by the powers vested in me by law, do hereby reorganize the Provincial Health Board as follows:
