EXECUTIVE ORDER NO. 08

CREATING AND ORGANIZING THE COMPOSITE TOBACCO PROJECT MANAGEMENT TEAM (CT- PMT) OF THE PROVINCE OF ISABELA

WHEREAS, it is the policy of the state to promote transparency, accountability, and the judicious use of resources in government;

WHEREAS, it is the intention of R.A. No. 8240 and R.A.10351 to benefit communities which have contributed to the production of native and burley tobacco;

WHEREAS, the Province of Isabela is both producing burley and native tobacco varieties with number of farmers indulge with the cultivation of said crops;

WHEREAS, the law mandates that the incremental revenue collected from the excise tax on tobacco products shall be allocated and divided among the LGUs producing burley and native tobacco;

WHEREAS, the fund shall be exclusively utilized for programs in pursuit of the objectives as enumerated in the law;

WHEREAS, in accordance with policy, there is a need to create a unit within the provincial government to be primarily responsible for the proper and smooth implementation and documentation of projects to be financed from the burley and native tobacco excise tax share of the Provincial Government of Isabela;

NOW THEREFORE, I, RODOLFO T. ALBANO III, Governor of the Province of Isabela, by virtue of the powers vested in me by law, do hereby decree the following:

Section 1. CREATION. There is hereby created and organized the Composite Tobacco Project Management Team (CT-PMT) of the province of Isabela.

Section 2. NATURE AND CHARACTER the Composite Tobacco Project Management Team shall be primarily responsible for the proper and smooth implementation of the 3 component projects to be financed under the Fiscal Year 2016 share for the excise tax.

They shall be responsible for the submission of monthly and quarterly reports and shall submit a terminal report copy furnished the Office of the President (OP), Commission on Audit (COA), Department of Budget and Management (DBM), Department of Interior and Local Government (DILG) and the Office of the Governor upon full implementation of the project;

Section 3. COMPOSITION. The Composite Tobacco Project Management Team shall be constituted as follows:

Section 4.FUNDING.Funding for the operations of the Composite Tobacco Project Management Team shall be sourced from the Office of the Provincial Governor Funds.

Section 5.REPEALING CLAUSE. All issuances, orders, rules and regulations, or parts thereof that are inconsistent with any provision of this Order are hereby repealed or modified accordingly.

Section 6.EFFECTIVITY.This Executive Order shall take effect immediately.
