EXECUTIVE ORDER NO. 09 -2019

REORGANIZING THE PROVINCIAL DEVELOPMENT COUNCIL OF THE PROVINCE OF ISABELA

WHEREAS, Section 106 of Republic Act 7160, otherwise known as the "Local Government Code of 1991," provides for the organization of local development councils that will initiate a comprehensive multi-sectoral development plan to be approved by their corresponding legislative board or Sanggunian;

WHEREAS, the local development council at the provincial, city, municipal, and barangay level, shall assist the corresponding Sanggunian in setting the direction of economic and social development, and in coordinating development efforts within its territorial jurisdiction;

WHEREAS, the change in the leadership of the province of Isabela after the elections of May 2019 and the separation, transfer and/or promotion from office of the members of the Provincial Development Council for the period July 2016 thru June 2019 warrants the reorganization and reconstitution of the Provincial Development Council of the province of Isabela;

NOW, THEREFORE, I, RODOLFO T. ALBANO III, Governor of the Province of Isabela, by virtue of the authority vested in me by law, do hereby reorganize and reconstitute the Provincial Development Council of the province of Isabela as follows:
