EXECUTIVE ORDER NO. 22 - 2019

DIRECTING THE ISABELA LOCAL SCHOOL BOARD AND THE SCHOOLS DIVISION SUPERINTENDENTS OF DEPED DIVISION OF ISABELA, CITY SCHOOL DIVISION OF CAUAYAN CITY, AND CITY SCHOOL DIVISION OF THE CITY OF ILAGAN, TO MONITOR SCHOOL ENROLMENT AND PARTICIPATION RATES, DROP-OUT AND COHORT SURVIVAL RATES, AND ACHIEVEMENT SCORES OF THE YOUTH OF ISABELA

WHEREAS, the Provincial Government of Isabela (PGI) pursues a policy of excellence in policy-making and program implementation;

WHEREAS, since 2011, the PGI has been a recipient of the highest awards in local governance conferred by the Department of the Interior and Local Government, in particular the *Seal of Good Local Governance* (SGLG), a yearly conferment recognizing an LGU's transparency and accountability and performance in financial housekeeping, disaster preparedness, environment protection, peace and order, business competitiveness, and responsiveness to the basic needs of health, education, and livelihood of the constituency;

WHEREAS, with the passage of Republic Act 11292 or the "*Seal of Good Local Governance Act of 2019*," the SGLG conferment has been institutionalized and local governments aspire more than ever, to enhance and strengthen their policy-making and program implementation, and hopefully be recognized for their performance and the quality and impact of their programs for the constituency;

WHEREAS, sustainable education initiatives are among the criteria for the annual DILG assessment of LGUs, and performance indicators are the positive results of Local School Board Policies and Programs, such as increased participation rate, lower drop-out rate, increase in cohort survival rate, higher achievement scores, and support for child development, special education, and alternative learning;

WHEREAS, there is a need for the Department of Education in Isabela and the PGI to work together in determining the performance of the school youth in order to determine gaps in the local basic education system and what reforms are needed to enhance the same;

NOW THEREFORE, I, RODOLFO T. ALBANO III, Governor of the Province of Isabela, by the powers vested in me by law, do hereby direct the Schools Division Superintendents of Deped Division of Isabela, City School Division of Cauayan City, and City School Division of the City of Ilagan, to monitor **SCHOOL ENROLMENT AND PARTICIPATION RATES, DROP-OUT AND COHORT SURVIVAL RATES, AND ACHIEVEMENT SCORES OF THE YOUTH OF ISABELA**.

The Schools Division Superintendents are also hereby directed to process and submit all data to the Office of the Governor on a regular basis.

All issuances, orders, rules and regulations, or parts thereof that are inconsistent with any provision of this Order are hereby repealed or modified accordingly.

This Executive Order shall take effect immediately.
