EXECUTIVE ORDER NO. 23 - 2019

REORGANIZING THE LOCAL COUNCIL FOR THE PROTECTION OF CHILDREN (LCPC) AND INSTITUTIONALIZING ITS BANNER PROJECT, UBING, OR UGNAYAN NG BATANG ISABELEÑO AT NAGBABANTAY NA GOBYERNO, AS THE OFFICIAL CHILD PROTECTION CENTER AND HOTLINE IN THE PROVINCE OF ISABELA

WHEREAS, it is the policy of the State as embodied in Presidential Decree No. 603, otherwise known as "The Child and Youth Welfare Code," to ensure the promotion of child welfare and enhance opportunities for children to have productive and happy lives;

WHEREAS, in accordance with policy, the Local Council for the Protection of Children (LCPC) of the province of Isabela was created and constituted in 2012 by an Executive Order issued by the Governor;

WHEREAS, the LCPC, while performing advisory, recommendatory, and coordinative functions in support of policy-making and implementation, has completed preparations for the launch of its most important project to date, **UBING**, or Ugnayan ng Batang Isabeleño at Nagbabantay na Gobyerno, which will serve as the *Official Child Protection Center and Hotline* in the province of Isabela;

WHEREAS, Project UBING was conceived to be an institutional mechanism that strengthens the exercise of children's rights, plans and recommends intervention, and monitors children's programs and projects, in close cooperation with the Provincial Inter-Agency Council Against Trafficking;

WHEREAS, the change in the leadership of the province of Isabela after the elections of May 2019 and the separation, transfer and/or promotion from office of the members of the LCPC have resulted in vacancies in the membership of the Council and in the deferment of the launch of UBING;

WHEREAS, there is a need to reorganize the LCPC to ensure continuity in the body's plans and projects for the protection of the children of Isabela;

NOW THEREFORE, I, RODOLFO T. ALBANO III, Governor of the Province of Isabela, by the powers vested in me by law, do hereby reorganize the LOCAL CHILD PROTECTION COUNCIL as follows:

Further, the institutionalization of PROJECT UBING as the banner project of the LCPC is hereby ordered in preparation for the operationalization of the project in the near future.

All Orders, circulars, memoranda, rules, regulations, and other issuances or parts thereof that are inconsistent herewith are hereby repealed, modified, or amended accordingly,

If any part or provision of this Executive Order is held invalid or unconstitutional, other provisions not affected thereof shall remain in full force and effect.

This Executive Order shall take effect immediately and let copies hereof be provided to all concerned for their information, reference, and guidance.
