EXECUTIVE ORDER NO. 28-E

RE-ESTABLISHING AND REORGANIZING THE PROVINCIAL E- CLIP COMMITTEE (ECC) IN COMPLIANCE TO THE PROVISION OF DEPARTMENT OF NATIONAL DEFENSE AND DILG JOINT MEMORANDUM CIRCULAR 2018-01 AND PROVIDING FUNDING THEREFORE

WHEREAS, the constitution declares that maintenance of peace and order, the protection of life, liberty, and property and the promotion of the general welfare are essential for the enjoyment by all the people of the blessings of democracy;

WHEREAS, the Local Government Code mandates Local Government Units (LGUs) to provide social welfare services which includes programs and projects for rebel returnees;

WHEREAS, a lasting peace calls for the pursuit of a comprehensive, integrated and holistic peace process to address the internal armed conflicts and the root causes involved, as well as, the implementation of programs to address the legal status and security of former rebels (FRs) and provision of community-based assistance to respond to their economic, social and psychological rehabilitation needs;

WHEREAS, the E- CLIP Program through the E- Clip Committee (ECC) shall focus to facilitate the mainstreaming of Former Rebels who were members of the Communist Party of the Philippines and Militia ng Bayan as productive citizens; Enhance capacities of LGUs and National Government Agencies in the implementation and sustainability of the program; and compensate and remunerate all turned-in- firearms;

WHEREAS, the Provincial Peace and Order Council (PPOC) shall serve as the convergence mechanism to support the E- Clip Committee in the implementation of the program, it shall provide synchronized, focused and vigorous orchestrated government efforts on the integration of FRs in the province;

WHEREAS, there is a need to further enhance the participation of the Local Government to the all- inclusive peace process by institutionalizing the program so that it can be implemented successfully;

NOW THEREFORE, I, RODOLFO T. ALBANO III, Governor of the Province of Isabela, by virtue of the powers vested in me by law, do hereby decree the re- establishment and reorganization of the E-CLIP Committee of the province of Isabela.

Section 2. NATURE AND CHARACTER. The E- CLIP Committee is an organizational unit that will implement the E- CLIP program in the province and shall develop E-CLIP committee Implementation Plan (ECCIP) which shall form part of the Peace and Order and Public Safety (POPS) Plan.

Section 3.COMPOSITION.The E- CLIP Committee shall be constituted as follows:

Section 4. FUNCTIONS. The E- CLIP COMMITTEE shall have the following functions



1. Lead in the management and implementation of the integration program for former rebels and ensure the sustainability and consistency of convergent effort in the delivery of the identified services of the program;
2. Ensure proper documentation and referral of the needs of the FRs;
3. Facilitate the profiling of the FRs, through PSWDO;
4. Assist the FR in completing the E- CLIP Enrollment Form. The FR should either sign or thumb mark the Form after completing it, attested by the DILG Provincial Director and approved by the Provincial Governor or by his/ her designated officer preferably the Provincial Administrator;
5. Assist the FR in the preparation of his/her Former Rebel Reintegration Plan (FRRP) and Business Plan with the PSWDO as the lead agency to assist FR. It shall have the option to come- up with its template (form)of FRRP and Business Plan, as long as the minimum datasets reflected in the Sample Forms in Annexes E and F of the IRR are considered;
6. Resolve issues and concerns affecting the implementation of the E- CLIP. Including but not limited to the legal status and security of FRs, processing of their application and LGUs, Government Organizations and Civil Society Organizations participation in the Program;
7. Provide updates to the PPOC during its meetings regarding the progress of E- CLIP; and
8. Coordinate and monitor the E- CLIP implementation in the Province.
9. Seek assistance from any and all government agencies in the region and province, as well as funding institutions, as may be necessary in the implementation and realization of the E-CLIP;
10. Propose to the SangguniangPanlalawigan local legislative measures, if necessary, for the smooth implementation of the E-CLIP;
11. Ensure the provision of guarantees for the safety and security of Former Rebels, in coordination/partnership/cooperation with the PNP and AFP, while they are enrolled under the E-CLIP;
12. Ensure the provision of psycho-social support to the Former Rebels, their families, and communities, and the sustainability of Healing and Reconciliation initiatives of the local government;

Section 5.FUNDING.Funding for the operations of the E- CLIP Committee shall be sourced from the Office of the Governor.

Section 6. REPEALING CLAUSE. All issuances, orders, rules and regulations, or parts thereof that are inconsistent with any provision of this Order are hereby repealed or modified accordingly.

Section 7.EFFECTIVITY.This Executive Order shall take effect immediately.
