EXECUTIVE ORDER NO. 28-F

### ORGANIZING THE COMMITTEE TO MONITOR LOCAL PEACE AND ORDER COUNCIL FUNCTIONALITIES

**WHEREAS**, it is the policy of the State to safeguard the integrity of its territory and the well-being of its citizenry, and provide effective mechanisms or measures to ensure public safety and law and order;

**WHEREAS**, Section 116 of Republic Act No. 7160, otherwise known as The Local Government Code of 1991, and pursuant to Executive Order No. 773, which calls for further reorganization of Local Peace and Order Councils (POC) in every province, city, municipality, and barangay;

**WHEREAS**, DILG Memorandum Circular No. 2015-130 was issued on 03 November 2015 to provide the guidelines for the strengthening of Local Peace and Order Councils, Barangay Peace and Order Committees, and the Peace and Order Council Secretariats, and DILG Memorandum Circular No. 2015-128 providing the guidelines for the formulation of the Peace and Order and Public Safety Plan (POPS PLAN);

**WHEREAS**, the Provincial Peace and Order Council provides a platform for stronger collaboration among stakeholders and creates an enabling environment amongst its members to effectively implement peace and order and public safety initiatives;

**WHEREAS**, to ensure that the local POC will efficiently perform their tasks, there is a need to create a committee that will monitor the functionalities of the council such as formulation of POPS Plan, the encoding of said POPS Plans in the POPS-PCMS, and other relevant policies relative to peace and order and public safety.

**NOW THEREFORE, I, RODOLFO T. ALBANO III**, Governor of the Province of Isabela, by virtue of the powers vested in me by law, do hereby decree the following:

**Section 1. Creation.** There is hereby created the Committee to monitor the Provincial Peace and Order Council Functionalities;

**Section 2. Composition.** The Committee shall be composed of the following:

WHEREAS, the Department of Justice (DOJ) Memorandum Circular (MC) No. 113-19, dated August 22, 2019, provides the guidelines for the reorganization of local law enforcement agencies through the creation of Law Enforcement Units (LEUs) and the reassignment of personnel; and

WHEREAS, the Provincial Police and Order Council (PPOC) is composed of representatives from the Provincial Police Office (PPO), the Provincial Public Safety Officer (PPSO), and the Provincial Public Safety Council (PPSC); and

WHEREAS, to ensure that the local law enforcement agencies are reorganized in a manner that is consistent with the guidelines provided by the DOJ MC No. 113-19, the PPOC is hereby directed to conduct a study on the reorganization of local law enforcement agencies in the Province of Isabela.

NOW, THEREFORE, I, RODOLFO T. ALBANO III, Governor of the Province of Isabela, by virtue of the powers vested in me by the Constitution and the Local Government Code of 1991, do hereby issue the following Executive Order:

**Section 1. Creation.** There is hereby created the Provincial Police and Order Council (PPOC) composed of the following members:
