EXECUTIVE ORDER NO. 31

REORGANIZING THE HUMAN RESOURCE MERIT PROMOTION AND SELECTION BOARD (HRMPSB) OF THE PROVINCIAL GOVERNMENT OF ISABELA

Whereas, it is the policy of the State to ensure the efficient delivery of public service by strengthening the government workforce through the Civil Service Commission (CSC), the central personnel agency of the government;

Whereas, the Civil Service Commission has caused the institutionalization and promulgation of the Personnel Mechanisms -to ensure the highest standards in personnel recruitment and human resource development and management within the government;

Whereas, the CSC urges all government offices, agencies, and local government units to adopt the Personnel Mechanisms to ensure the quality of public service delivery and the responsiveness of the government to the needs of the people;

Whereas, there is a need for the Provincial Government of Isabela to adopt and implement the Merit Personnel Mechanisms (MSP) promulgated by the CSC to enhance public service delivery, ensure the attainment of the highest standards of personnel recruitment, human resource development and management, and promote the ideals of governance;

Now therefore, I, **RODOLFO T. ALBANO III**, Governor of Isabela, by virtue of the powers vested in me by law, do hereby issue this order, reorganizing the Human Resource Merit Promotion and Selection Board (HRMPSB) of the Provincial government of Isabela.
