EXECUTIVE ORDER NO. 38 - 2019

**CREATING THE ISABELA CONSTRUCTORS' PERFORMANCE EVALUATION SYSTEM
IMPLEMENTING UNIT (ICPES -IU) FOR THE EFFECTIVE IMPLEMENTATION
OF ALL GOVERNMENT INFRASTRUCTURE PROJECTS IN THE PROVINCE**

WHEREAS, it is the policy of the State to ensure the safe and efficient use of all infrastructure projects by the public, by engaging the services of only qualified and reliable contractors, and by ensuring compliance with minimum safety standards as provided under existing laws and statutes;

WHEREAS, the Department of the Interior and Local Government (DILG) encourages local government units to create a body that will apply a system of evaluation of contractors implementing infrastructure projects as a mechanism to achieve improved quality of infrastructure projects;

WHEREAS, numerous agencies are funding and implementing various infrastructure projects in different areas in the province and a special body will be helpful in achieving improved quality and efficiency of the infrastructure projects;

WHEREAS, in accordance with policy, there is a need for the Provincial Government of Isabela to create a body that will oversee the performance of individuals and organizations involved in the implementation of all infrastructure projects within the province;

Now therefore, I, **RODOLFO T. ALBANO III**, Governor of Isabela, by virtue of the powers vested in me by law, do hereby decree the following:

Section 1. CREATION. There shall be created a Constructors' Performance Evaluation System-Implementing Unit (CPES-IU) for all infrastructure projects undertaken in the province of Isabela. The body shall be called Isabela CPES-IU or ICPES-IU.

Section 2: FUNCTIONS. The Isabela CPES-IU shall have the following functions:

- a. Take the lead in implementing mechanisms and standards for the effective performance of all individuals and organizations involved in all general infrastructure projects within the province of Isabela, such as, but not limited to, training in Quality Control/Assurance/Materials Testing, Project Management/Supervision/Monitoring, Construction Safety, Environmental Assessment, and other related courses;
- b. Convene regularly to perform planning, management and implementation, monitoring, evaluation, and coordinative functions to promote efficient and effective performance;
- c. Ensure that the ICPES-IU's functions are carried out and applied in all infrastructure projects province-wide;

- d. Endorse personnel for accreditation by the Philippine Domestic Construction Board (PDCB), including individuals and employees who have successfully passed the Case Study component of CPES Accreditation Seminar Workshops;
- e. Furnish the Office of the Governor copies of any and all reports or important documents pertinent to the work of the ICPEI-IU ;
- f. Perform such other functions as may be necessary to meet the objectives of this Order.

Section 3. COMPOSITION. The ICPEI-IU shall be composed of the following:

Section 4. FUNDING. The funding requirements for the operations of the ICPEI-IU shall be sourced from Funds under the Office of the Governor, subject to the usual budget, accounting, and auditing rules and regulations.

Section 5. REPEAL, All Orders, circulars, memoranda, rules, regulations, and other issuances or parts thereof that are inconsistent herewith are hereby repealed, modified, or amended accordingly.

Section 6. SEPARABILITY. If any part or provision of this Executive Order is held invalid or unconstitutional, other provisions not affected thereof shall remain in full force and effect.

Section 7. EFFECTIVITY. This Executive Order shall take effect immediately.
