CREATING THE PLANNING TEAM FOR THE ISABELA LOCAL INVESTMENT PLAN FOR HEALTH AND THE ANNUAL OPERATIONAL PLAN (ILIPH- AOP PT)

WHEREAS, the Department of Interior and Local Government (DILG) in Joint Memorandum Circular No. 2007-001 provides guidelines on the harmonization of local planning, investment programming, revenue administration, budgeting & expenditure management and strengthen the interface between local government units (LGUs) and national government agencies (NGAs).

WHEREAS, pursuant to relevant provisions of the Local Government Code (LGC) of 1991, all LGUs shall prepare their comprehensive development plans, Local Development Investment Programs (LDIPs), Annual Investment Programs (AIPs), Annual and Supplemental Budgets in the context of and in harmony with national and regional policies, goals and strategies.

WHEREAS, All LGUs in coordination with NGAs, Government Owned and Controlled Corporations, Government Financial Institutions shall adhere to the provisions of law and principle of complementation and participation between and among LGUs and private sector/non-government organizations in the preparation of their plans and budgets;

WHEREAS, the Local Investment Plan for Health (LIPH), a 3 –year plan comprehensive planning exercise as the key instrument to carry out the plans, projects and activities in realizing the integration of local health system at the province/city level that support the Philippine Development Plan(PDP) towards achieving health-related Sustainable Development Goals(SDGs);

WHEREAS, the approved LIPH and AOP shall be utilized to leverage better performance and focus on the achievement of improved local health system performance consistent with the *Universal Health Care Fourmula One Plus(F1+) For Health, National Objectives for Health and LGU Scorecard for Health*

NOW THEREFORE, I, Rodolfo T. Albano III, Governor of the Province of Isabela, by virtue of the powers vested in me by law, hereby decree the following:

Section 1. Creation. THE PLANNING TEAM FOR ISABELA LOCAL INVESTMENT PLAN FOR HEALTH AND THE ANNUAL OPERATION PLAN (ILIPH-AOP PT) is hereby created.

Section 2. Composition. The ILIPH-AOP PT shall be composed, to wit:

Section 3. Functions and Responsibilities. The ILIPHPT shall perform the following functions:

1. Craft an integrated plan reflecting the programs and projects of different health programs based on the current thrusts of the Provincial and National Government;
2. Source-out funding for health activities not funded by DOH or development partners;
3. Ensure participation of Civic Society Organizations(CSOs),private health sector stakeholders in both planning process and implementation of LIPH/AOP;
4. Monitor the implementation of the LIPH/AOP thru the designated Technical Working Group(TWG)
5. Submit Fund Utilization Reports to DOH ROs, the frequency of which is determined and agreed by both LGUs and DOH;
6. Convene regular meeting of the team as need arises
7. Ensure timely submission of integrated and consolidated LIPH/AOP to CVCHD based on agreed timelines;
8. Perform other functions as may be necessary to accomplish the objectives of this Executive Order.

Section 4. Designation of Focal Persons. DR. MARICHU S. MANLONGAT, Rural Health Physician to be assisted by MS. PATRIA BAGAOISAN, Nurse IV, MS. JESUSA ALINDADA, Supervising Administrative Officer, from Field Health Services and MS. GERTRUDES YAP, Supervising Administrative Officer of Echague District Hospital from the Hospital Services, are hereby designated FOCAL PERSONS of the Isabela Local Investment Plan for Health (LIPH) Planning Team, to ensure accuracy, completeness and full implementation of this Order.

Section 5. Effectivity. This Executive Order shall take effect immediately.
