EXECUTIVE ORDER NO. 46-B - 2019

### RE-ORGANIZING THE APPRAISAL TEAM FOR THE ISABELA LOCAL INVESTMENT PLAN FOR HEALTH AND THE ANNUAL OPERATIONAL PLAN

**WHEREAS**, the Department of Interior and Local Government (DILG) in Joint Memorandum Circular No. 2007-001 provides guidelines on the harmonization of local planning, investment programming, revenue administration, budgeting & expenditure management and strengthen the interface between local government units (LGUs) and national government agencies (NGAs).

**WHEREAS**, pursuant to relevant provisions of the Local Government Code (LGC) of 1991, all LGUs shall prepare their comprehensive development plans, Local Development Investment Programs (LDIPs), Annual Investment Programs (AIPs), Annual and Supplemental Budgets in the context of and in harmony with national and regional policies, goals and strategies.

**WHEREAS**, the Department of Health has developed the *FOURmula One Plus for Health (F1+)* as the Strategic Framework that describes pillars and key interventions, organizational and policy changes as well as public investments needed to improve the way health care are governed, delivered, financed and regulated while emphasizing the importance of performance accountability to all Filipinos through the Local Investment Plan for Health (LIPH) 2020-2019;

**WHEREAS**, the LIPH and AOP shall reflect health needs of the barangays, cities and municipalities are integrated to develop province-wide health plan to ensure equitable, effective and efficient health care.

**NOW THEREFORE**, I, Rodolfo T. Albano III, Governor of the Province of Isabela, by virtue of the powers vested in me by law, hereby decree the following:

**Section 1. Re-organization.** THE APPRAISAL TEAM FOR THE ISABELA LOCAL INVESTMENT PLAN FOR HEALTH (LIPH) AND THE ANNUAL OPERATIONAL PLAN is hereby re-organized.

**Section 2. Composition.** The ILIPH/AOP AT shall be composed, to wit:

**Section 3. Functions and Responsibilities.** The ILIPH/AOP AT shall perform the following functions:

1. Ensure health plans are integrated and consolidated for the province-wide LIPH and AOP ;
2. Conduct initial review and appraisal of the province-wide LIPH and AOP using the prescribed DOH Appraisal Checklist;
3. Set up Monitoring and Evaluation Team for the implementation of the LIPH/AOP;
4. Approve counter-part funding for health activities when feasible not funded by DOH or Development Partners
5. Submit Fund Utilization Reports to CVCHD, the frequency of which is determined And agreed by both LGU and CVCHD;
6. Perform other functions as may be necessary to accomplish the objectives of this Executive Order.

**Section 4. Funding.** The funding requirements for the operations of the ILIPH-AOP PT shall be sourced from the Office of the Governor, subject to the usual budget, accounting and auditing rules and regulations.

**Section 5. Effectivity.** This Executive Order shall take effect immediately.
