EXECUTIVE ORDER NO. 53 - 2019

CREATING THE ISABELA PROVINCIAL CENSUS COORDINATING BOARD (IPCCB) FOR THE 2020 CENSUS OF POPULATION AND HOUSING (CPH 2020)

WHEREAS, Batas Pambansa (BP) Blg. 72 provides for the taking of an integrated census every ten (10) years beginning in 1980;

Whereas, BP 72 also provides that Census Coordinating Boards are to be created to ensure the systematic coordination of government agencies and instrumentalities in the conduct of the Census;

Whereas, Executive Order no. 352 – “ Designation of Statistical Activities that will Generate Critical Data for Decision- Making of the Government and the Private Sector” stipulates the conduct a census of population and housing every ten years primarily to come up with population figures at the national down to barangay levels;

Whereas, the Census Coordinating Boards shall issue such rules and regulations as may be necessary to successfully carry out the Census undertaking, and shall provide such facilities and assistance as may be required for the conduct of the Census;

Whereas, the CPH 2020 will be a nationwide government undertaking that involves the collection, compilation, evaluation, analysis, publication and dissemination of data on population count, demographic and socio- economic characteristics of the population, housing characteristics, and barangay characteristic in each barangay, city/municipality, province and region in the country;

Whereas, recognizing the increasing importance of the census data in meeting data needs at the lowest geographic level, the assistance provided by government agencies, government-owned and controlled corporations and local government units to the PSA, will be instrumental to the success of the CPH 2020;

Whereas, the PSA approved Board Resolution no. 05 S. 2019, creating the Regional, Provincial, City, and Municipal Census Coordinating Boards to ensure cooperation of all government and private entities and smooth flow of Census operations at all geographic and administrative levels;

Now therefore, I, **RODOLFO T. ALBANO III**, Governor of Isabela, by virtue of the powers vested in me by law, do hereby decree the following:

Section 1. Creation. There is hereby created the Isabela Provincial Census Coordinating Board (IPCCB) for the 2020 Census of Population and Housing (CPH 2020).

Section 2. Functions. The IPCCB- CHP 2020 shall have the following functions;

1. Assess the needs of the PSA in the province in terms of facilities (transportation, communications, training, and lodging), security, publicity, and other logistics;
2. Provide transportation facilities for the distribution/ delivery of census materials and supplies and transmittal of census returns, before, during, and after the census operations;
3. Provide communications facilities for use of census personnel;
4. Provide venues/ facilities for the training of census personnel;
5. Provide temporary office/room/ space that will serve as headquarters of census personnel or storage area for census materials and supplies for the duration of the census operations;

6. Assist the City/Municipal Census Coordinating Board in the conduct of publicity and information campaign;
7. Provide facilities for lodging of census personnel assigned in areas outside of their official station;
8. Assist the PSA in the census operations to ensure complete coverage of the province;
9. Specify other areas of involvement or participation of the agencies within the limits of their resources;
10. Refer to the RCCB matters which cannot be resolved by the PCCB; and
11. Take up other matters as may be specified by the RCCB or as necessary for the successful conduct of the census.

Section 3. Composition.

The Isabela PCCB –CHP 2020 shall be constituted, to wit:
