EXECUTIVE ORDER NO. 11 -2020

CREATING THE LOCAL RESILIENCE READINESS MONITORING FRAMEWORK (LRRMF) TECHNICAL TEAM FOR THE PROVINCE OF ISABELA

WHEREAS, it is the policy of the State to uphold the people's constitutional right to life and property by addressing the root causes of vulnerabilities to disasters, strengthening the country's institutional capacity for disaster risk reduction and management (DRRM), and building the resilience of local communities to disasters, including climate change impacts;

WHEREAS, RA 10121, otherwise known as "Disaster Risk Reduction and Management Act of 2010" provides that LGUs shall ensure the integration of disaster risk reduction and climate change adaptation into local development plans, programs and budgets as a strategy in sustainable development and poverty reduction;

WHEREAS, it is the mandate of the law that Local Government Units shall be the frontline agencies in the formulation, planning and implementation of Disaster Risk Reduction Management and Climate Change Adaptation (DRRM-CCA) in their respective area of responsibility;

WHEREAS, in view of the increasing complexities posed by escalating disaster risks, the Department of the Interior and Local Government (DILG) in partnership with Agence Francaise de Developpement (AFD) has developed the Local Resilience Readiness Monitoring Framework (LRRMF);

WHEREAS, the LRRMF as an adaptable assessment tool broadens the scope of disaster preparedness expected from LGUs to prepare for long-term risk, imminent threats and recovery in the event of a disaster;

WHEREAS, there is a need to create the Isabela Resilience Readiness Monitoring Framework Technical Team who will closely and collaboratively work for the successful adoption and implementation of Local Resilience Readiness Monitoring Framework for the Province of Isabela pursuant to DILG Memorandum Circular 2020-043;

NOW THEREFORE, I, **RODOLFO T. ALBANO III**, Governor of Isabela, by virtue of the powers vested in me by law, do hereby decree the following:

Section 1. Creation. There is hereby created an Isabela Resilience Readiness Monitoring Framework Technical Team (IRRMFTT) to spearhead the adoption and implementation of Local Resilience Readiness Monitoring Framework of the province.

Section 2. Functions. The Technical Team shall have the following functions;

1. Coordinate with the Isabela Provincial Disaster Risk Reduction Management Council (PDRRMC) and other offices to gather support, documents, data and inputs for the implementation of LRRMF;
2. Designate focal person/s responsible for gathering documents and data consolidation and entry;
3. Facilitate field visits by DILG Assessment Teams;
4. Utilize LRRMF results to inform the local planning process and the creation/ updating of plans, i.e. Provincial Development and Physical Framework Plan, Comprehensive Land Use Plans, Disaster Risk Reduction Management Plans and other related plans, and to guide mobilization of resources.
