EXECUTIVE ORDER NO. 39
Series of 2020

RECONSTITUTING THE LOCAL ROAD MANAGEMENT TEAM (LRMT) AND TECHNICAL WORKING GROUP (TWG) OF THE PROVINCE OF ISABELA

WHEREAS, the Department of the Interior and Local Government (DILG) in partnership with the Department of Budget and Management (DBM) implemented a national program to fund road repair, rehabilitation, and improvement in all provinces that are compliant with the Good Financial Housekeeping component of the Seal of Good Local Government (SGLG) of the DILG;

WHEREAS, the national program, dubbed as Conditional Matching Grant to Provinces (CMGP), is the successor of the KALSADA (Konkreto at Ayos na LanSangan: ang DAan Tungo sa Pangkalahatang Kaunlaran) program;

WHEREAS, the DILG Memorandum Circular No. 2017-159 dated 21 November 2017, states that Provincial Government shall designate a committed and capable Local Road Management Team (LRMT) with expertise in developing all components of the LRNDP and facilitating its development;

WHEREAS, the Provincial Government of Isabela is determined to ensure the smooth and effective implementation of the CMGP projects in the province, in accordance with policy;

NOW THEREFORE, I, RODOLFO T. ALBANO, III, Governor of the Province of Isabela, by virtue of the power vested in me, do hereby decree the following:

Section 1. Reconstitution of the LRMT and TWG. The Creation of the LRMT which shall be responsible for managing all concerns on road management and public financial management as determined by CMGP;

Section 2. Nature and Character. The LRMT shall be a unit under the Office of the Governor tasked to manage the implementation of CMGP projects in Isabela and coordinate with the DILG and the DBM in the process.

Section 3. Functions. The LRMT shall have the following duties and functions:

- a. Be responsible in the implementation of all CMGP projects in Isabela towards the attainment of the envisioned socio-economic benefit of the province;
- b. Ensure the day-to-day supervision of construction/implementation of activities under the CMGP program;
- c. Ensure that all CMGP priority projects are in accordance with existing policies and infrastructure development plans;
- d. Prepare periodic reports to concerned agencies on the status and progress of project implementation;
- e. Convene regularly to perform planning, management and implementation, monitoring, evaluation and coordinative functions to promote efficient and effective performance;

- f. Perform such other functions as may be necessary to meet the objectives of this Order.
