EXECUTIVE ORDER NO. 02 -2020

**ENJOINING THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS,
DEPARTMENT OF EDUCATION, STATE UNIVERSITIES AND COLLEGES IN THE
PROVINCE AND DIRECTING THE PROVINCIAL GOVERNMENT TO INCORPORATE
IN THEIR PROGRAM OF WORK (POW) PROVISIONS FOR WATER HARVESTING
AND LED LIGHTING FACILITY ON ALL PROPOSED SCHOOL
AND GOVERNMENT BUILDINGS**

Whereas, the 1987 Constitution provides that it is a State Policy to “protect and advance the right of the people to a balanced and healthful ecology in accord with the rhythm and harmony of nature” (Section 16, Article II);

Whereas, RA 7616 declares that it is a national policy to promote the quality of life of every Filipino through the provision of adequate social service including, but not limited to, the provision of adequate water supply;

Whereas, Executive Order no. 45 S. 2019 issued by the undersigned, enjoins all schools in the province to apportion a budget to facilitate the establishment of rain harvesting facility in their proposed and existing buildings for non- potable and sanitation purposes;

Whereas, there is now an urgent need to properly manage the utilization of the province’s water and energy resources to ensure that human and economic needs are provided for in a sustainable way;

Whereas, water and energy as precious commodities should be conserved and optimally utilized, it is imperative therefore that a sustainable conservation program must be in place and implemented through coordinative, consultative and mutually-supportive mechanisms where all sectors plays an active role;

Whereas, the Provincial Government of Isabela recognizes the necessity of proper harvesting, storage, utilization of rainwater as a viable alternative source of water supply, primarily for non- potable use and even as potable water when appropriate technology is already available;

Whereas, to maintain the Government’s sincerity in promoting energy efficiency and conservation measures by all sectors, the Government shall lead in implementing energy management initiatives;

NOW THEREFORE, I, RODOLFO T. ALBANO III, Governor of Isabela, by virtue of the powers vested in me by law, do hereby enjoins the Department of Public Works and Highways, Department of Education, State Universities and Colleges in the province of Isabela and directing the Provincial Government to incorporate in their Program of Work (POW) provisions for water harvesting and led lighting facility on all proposed school and government buildings.

Further, the Office of the Provincial Engineer shall coordinate with the District Engineers, School Division Heads, SUC Presidents and all concerned agencies in the province for the effective implementation of this Executive Order. For compliance, submission of POW to include the stated requirements to the Office of the Governor prior to project implementation is a must;

Furthermore, let copies hereof be furnished the Sangguniang Panlalawigan for the Body's subsequent approval and adoption, and other offices for their information and reference.

This Executive Order shall take effect immediately.
