### **EXECUTIVE ORDER NO. 17** Series of 2021

#### **RE-ORGANIZING THE MICRO, SMALL, AND MEDIUM ENTERPRISES DEVELOPMENT (MSMED) COUNCIL OF THE PROVINCE OF ISABELA.**

**WHEREAS**, it is the policy of the State to foster a dynamic SME sector, and to promote, promulgate, develop, strengthen and provide assistance programs for micro, small and medium scale enterprises;

**WHEREAS**, the existing Micro, Small and Medium Enterprise Development Council, which was created by the Republic Act No. 6977, as amended by Republic Act No. 8289, as amended by Republic Act No. 9501, shall be strengthened to effectively spur the growth and development of MSMEs throughout the country, and to carry out the policy declared in the Act;

**WHEREAS**, in accordance with policy, Executive Order No. 19-A issued on 10 August 2016, organizing the Micro, Small and Medium Enterprises Development (MSMED) Council of the Province of Isabela;

**WHEREAS**, it is the policy of the Provincial Government of Isabela to further strengthen the capacity of small-scale businesses, support their growth, encourage new investments, and promote investment expansion in the province;

**WHEREAS**, in accordance with policy and due to the separation, transfer, and/or personnel movement in many of the member-agencies and offices of the original members of the Provincial MSMED Council, there is a need to re-organize the same to ensure the sustained and enhanced implementation of plans, programs, and activities stipulated in the Provincial MSMED Plan;

**NOW THEREFORE, I, RODOLFO T. ALBANO III**, Governor of the Province of Isabela, by virtue of the powers vested in me by law, do hereby reorganize the “**Micro, Small, and Medium Enterprise Development (MSMED) Council**” of the Province of Isabela as follows:
