### **CREATING THE PROVINCIAL CAPACITY DEVELOPMENT TEAM FOR THE PROVINCE OF ISABELA**

**WHEREAS**, the National Government is fully committed to the policy of decentralization enshrined in the constitution and other relevant laws and through Executive Order No. 138 Series of 2021, the President ordered the full devolution of certain functions of the Executive Branch to Local Governments and the creation of Committee on Devolution, and for other purposes;

**WHEREAS**, in view of the full devolution of certain functions from the NGAs, the provinces, cities, and municipalities are directed to formulate their Capacity Development Agenda based on the assessment framework and guidelines to be issued by the DILG-LGA. The Capacity Development Agenda shall be guided by, among others, the strategy to enable the LGUs to absorb, manage, and sustain the responsibilities under a fully devolved set-up;

**WHEREAS**, pursuant to Rule IX on the Implementing Rules and Regulations of Executive Order No. 138 there is a need for the creation of a Capacity Development Team to formulate the Capacity Development Agenda for the province of Isabela upon creation of the Devolution Transition Plan;

**NOW THEREFORE, I, RODOLFO T. ALBANO III**, Governor of the Province of Isabela, by virtue of the powers vested in me by law, hereby decree the following:

**SECTION 1. CREATION.** THE PROVINCIAL CAPACITY DEVELOPMENT TEAM FOR THE PROVINCE OF ISABELA is hereby created.

**SECTION 2. COMPOSITION.** The Provincial CAPDEV Team shall be composed of, to wit:
