EXECUTIVE ORDER NO. 30 - 2021

**CREATING THE EXECUTIVE COMMITTEE (EXECOM) OF THE
PROVINCIAL DISASTER RISK REDUCTION AND MANAGEMENT COUNCIL**

WHEREAS, Republic Act No. 10121 otherwise known as "AN ACT STRENGTHENING THE PHILIPPINE DISASTER RISK REDUCTION AND MANAGEMENT SYSTEM, PROVIDING FOR THE NATIONAL DISASTER AND MANAGEMENT FRAMEWORK AND INSTITUTIONALIZING THE NATIONAL DISASTER RISK REDUCTION AND MANAGEMENT PLAN, APPROPRIATING FUNDS THEREFOR AND FOR OTHER PURPOSES", provides for the organization at the local governance level of the Provincial Disaster Risk Reduction and Management Council (PDRRM);

WHEREAS, the Provincial Governor and Chairman of the Provincial Disaster Risk Reduction and Management Council issued Executive Order No. 22-2021 on June 15, 2021, "REORGANIZING THE PROVINCIAL DISASTER RISK REDUCTION MANAGEMENT COUNCIL" due to the movement, transfer and retirement from office of the other members of the PDRRM Council;

WHEREAS, the surge of SARS-CoV2 (Covid-19) continue to rise preventing the movement of people in the province;

WHEREAS, the Provincial Governor ordered to divide the work rotation schedule in two (2) work teams; a work team reporting on Mondays, Wednesdays an Fridays (MWF) and another work team on Tuesdays and Thursdays (TTh), as additional preventive measures and ensure the safety of employees in their work places and prevent disruptions in the efficient and effective delivery of public service;

WHEREAS, there is a need to control and prevent the spread of SARS-CoV2 (Covid-19) in the province, hence, "Face-to-Face" Meetings is highly discouraged;

WHEREAS, during the 3rd Quarter Regular PDRRM Council Meeting held last September 15, 2021, there was a *motion and unanimously seconded* by the body to "create an Executive Committee of the PDRRM Council to enable the Council to act and decide expeditiously urgent matters without necessarily requiring the attendance of a full Council consisting of sixty one (61) Regular Members, due to the continuing surge of Covid-19 in the province."

NOW THEREFORE, I RODOLFO T ALBANO III, Governor of the Province of Isabela, by the powers vested in me by law, do hereby order the Creation of the "Executive Committee of the Provincial Disaster Risk Reduction and Management Council (PDRRM)" composed of select Regular Members of the PDRRM Council, "whose primary function is to act on urgent matters expeditiously pertaining to Disaster Prevention and Mitigation, Disaster Preparedness, Disaster Response, Disaster Rehabilitation and Recovery of the Province in times of disasters, calamity and other forms of emergency", as follows:

In the absence of the EXECOM Member, the Assistant or the next ranking member of his/her office shall represent him/her in the proceedings of the Council Meeting.

All Orders, Circulars, Memoranda, Rules Regulations and other issuances or parts thereof that are inconsistent herewith are hereby repealed, modified or amended accordingly.
