EXECUTIVE ORDER NO. 10 Series of 2022

REORGANIZING THE LOCAL COUNCIL FOR THE PROTECTION OF CHILDREN (LCPC) AND REINSTITUTION OF ITS BANNER PROJECT, UBING, OR UGNAYAN NG BATANG ISABELEÑO AT NAGBABANTAY NA GOBYERNO, AS THE OFFICIAL CHILD PROTECTION CENTER AND HOTLINE IN THE PROVINCE OF ISABELA

WHEREAS, it is the policy of the State as embodied in Presidential Decree No. 603, otherwise known as “The Child and Youth Welfare Code,” to ensure the promotion of child welfare and enhance opportunities for children to have productive and happy lives;

WHEREAS, in accordance with the policy, the Local Council for the Protection of Children (LCPC) of the province of Isabela was created and constituted in 2012 by an Executive Order issued by the Governor;

WHEREAS, the separation, transfer and/or promotion from office of the members of the LCPC have resulted in vacancies in the membership of the Council;

NOW THEREFORE, I, **RODOLFO T. ALBANO III**, Governor of Isabela, by virtue of the powers vested in me by law as governor of the Province of Isabela, hereby reconstitute the Local Council for the Protection of Children (LCPC) of the province of Isabela, as follows:
