EXECUTIVE ORDER NO. 12 Series of 2022

REORGANIZING THE PROVINCIAL HEALTH BOARD OF THE PROVINCE OF ISABELA

WHEREAS, SECTION 102 of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides for the creation and composition a local health board in every province, city, or municipality;

WHEREAS, the separation, transfer and/or promotion from office of the members of the Provincial Health Board for the period July 2019 thru June 2022, have resulted in vacancies in the membership of the Board;

WHEREAS, there is a need to reorganize the Provincial Health Board to ensure the continuity and responsiveness of the provincial government's health plans and programs for the people of Isabela;

NOW THEREFORE, I, RODOLFO T. ALBANO III, Governor of the Province of Isabela, by the powers vested in me by law, do hereby reorganize the Provincial Health Board as follows:

Section 1. Meetings and Quorum.

a) The board shall meet at least once a month or as may be necessary.

(b) A majority of the members of the board shall constitute a quorum, but the chairman or the vice- chairman must be present during meetings where budgetary proposals are being prepared or considered. The affirmative vote of all the majority of the members shall be necessary to approve such proposals.

Section 2. Compensation and Remuneration.

The chairman, vice-chairman, and members of the provincial, city or municipal health board shall perform their duties as such without compensation or remuneration. Members thereof who are not government officials or employees shall be entitled to necessary traveling expenses and allowances chargeable against the funds of the local health board concerned, subject to existing accounting and auditing rules and regulations.

All Orders, circulars, memoranda, rules, regulations, and other issuances or parts thereof that are inconsistent herewith are hereby repealed, modified, or amended accordingly,

If any part or provision of this Executive Order is held invalid or unconstitutional, other provisions not affected thereof shall remain in full force and effect.

This Executive Order shall take effect immediately and let copies hereof be provided to all concerned for their information, reference, and guidance.
